### Entries and Payment:

- **Entries close** September 18<sup>th</sup>, 2022 at 11:00 am
- **Entry draw** will take place on September 18<sup>th</sup> at 11:30 am at 10970 284<sup>th</sup> Street Maple Ridge. This is a public draw and entrants and alternates will be notified by email as soon as possible following the draw.

- Receipt of entry will be acknowledged by email from the Test Secretary
- Cheques payable to NSDTR Club of Canada
- US entries may pay by money order in Canadian funds or personal cheque in US funds for the full amount
- There will be an NSF service charge fee of 30.00, an NSF cheque shall be considered non-payment of entry fees and is an offense punishable by disciplinary action and cancellation of awards by the CKC.
- Cheques for entries not drawn will be destroyed or you can request to have it returned to you by mail. Please specify at time of entry.

**Meeting place and draw for tracks on test day:** The meeting place for the TD and TDX draw on test day is to be determined, the time for the TD entry track draw will be at 7:15 am and the draw for TDX will be at 11:00. You will be informed of the location for the draw at the time of notification of the draw results.

**Refunds:** If a dog is withdrawn after the closing date refunds will only be given if their place is taken by an alternate. Alternates will be contacted in catalogue order and advised of an opening.

**Prizes:** All exhibitors receiving a “pass” will be awarded a ribbon

**Bitches in season:** Any bitch in season will run last, please advise the test secretary prior to the draw if your bitch is in season.

**Awards and no-host lunch:** Awards will take place after the last track is run, you are welcome to bring your lunch, this will take place outdoors.

**Discipline Regulation:** “It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules, is not subject to indignities of any kind. The Tracking Test Committee Chair shall promptly report to the CKC any infringement of this regulation and the Discipline committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.”

**Non-member participation fee:** A participation fee will be charged to a resident of Canada who is not a member of the CKC. The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual. In order for the title to be awarded the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level. This applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members

**Limit of Liability:** The Nova Scotia Duck Tolling Retriever Club of Canada and the landowners will not be responsible for any loss, damage or injury to any dog, exhibitor or vehicle.
