OFFICIAL JUDGING SCHEDULES

This schedule is based on 25 dogs per hour in Conformation, 8 dogs per hour in Novice Obedience, 7 dogs per hour in Open Obedience, and 6 dogs per hour in Utility. Rally 20 dogs per hour. Conformation Group judging will follow breed judging. Order of Best in Show Judging will be determined during afternoon judging.
