7. All entries must be accompanied by the entry fee (and listing fee of \$10.50 if applicable). The listing fee of \$10.50 (GST included) per dog per event is payable unless the dog entered has a CKC individual registration number or ERN number.
8. **NO PHONE/FAX ENTRIES or E-TRANSFER PAYMENTS WILL BE ACCEPTED.**  
**NOTE: To all Canadian residents only CKC rule**  
Non-member participation fee:
  - A. A non-member participation fee, for awards and titles will be charged to a Canadian non-member of CKC.
  - B. To protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.

## AWARDS

Standard CKC Rosettes to all dogs qualifying in each event.

## SCRATCHES

Scratches for a bitch in season shall be refunded in full. All other scratches will be refunded at the hunt test committee's discretion, other than a scratch fee of \$10.00. Prior to paying such a refund, the club may require an appropriate veterinary certificate. Refunds must be requested in writing to the Hunt Test Secretary no later than seven days after the test event, explaining the reason for the scratch.

## **BIRDS**

Local game birds including but not limited to ducks, pheasants, chukars or guinea hens may be used. Live pigeons may be used for the upland hunting test in the Master Hunt Tests

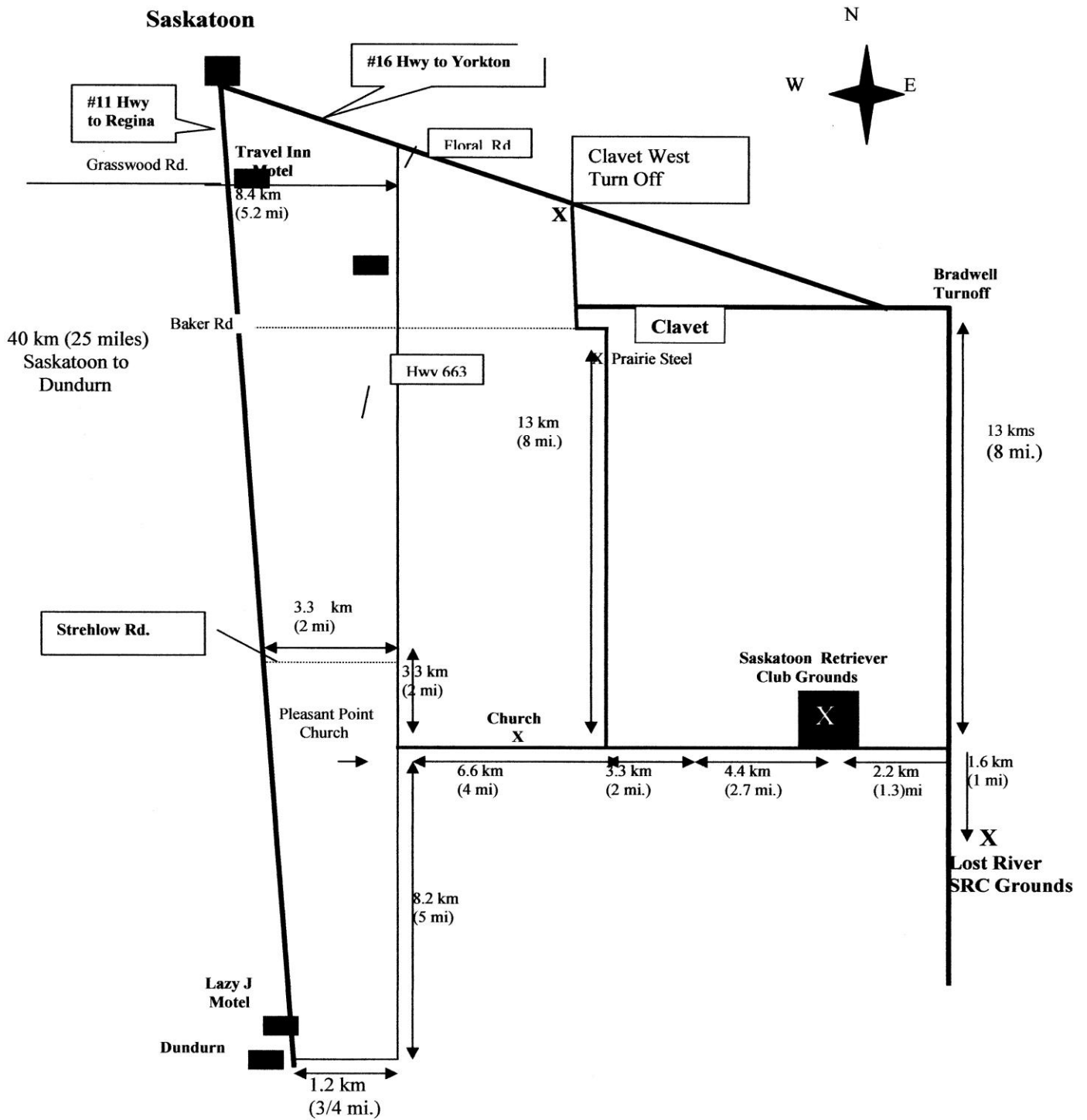
