Confirmations will be emailed shortly after the closing date for the trial.

All dogs must have a CARO Registration Number that must be on the entry forms.

Note: CARO regulations require the owner to obtain a CARO number directly from CARO. If you do not have a CARO Reg. # card for your dog, complete the Individual Dog Application form, found on www.canadianrallyo.ca and submit it directly to Caro. Please note that it takes several weeks to get a CARO Reg. #. A valid CARO Dog Reg. # card must be presented at the trial check-in, otherwise the dog will not be permitted to compete at this trial.

Awards

- Qualifying Ribbons for CARO qualifiers.

Facilities:

- The trial will be held at the Regina Kennel and Obedience Club (RKOC) indoor facility
- This is a one-ring event.
- A crating area is available inside the building
- Competitors are responsible for their own crating, seating, food & water.
- Self-serve coffee and tea will be available.
- No Canteen on premises, competitors are responsible for their own meals.

Dogs:

- All dogs must be kept in a crate or on leash when not in the ring (due to limited space, no x-pens allowed)
- Handlers are responsible to keep their dogs quiet at all times.
- Handlers are responsible to clean up after their dogs. Clean up baggies will be provided.
- Handlers are responsible to ensure the dogs do not eliminate in the front of the building or on neighbouring areas. There is an x-pen available in the back of the building for the dogs.
- Any dog engaging in aggressive behaviour at any time will be required to leave the trial grounds. There will be no refund of fees in such instances.
- Any handler displaying inhumane or aggressive treatment of any dog, or other participants, judges or volunteers, be it physically or verbally, while on site, will be asked to leave the trial grounds. There will be no refund of fees in such instances and all legs earned will be null and void.

Move Ups: Will be permitted providing the Trial Secretary is informed in writing at least one (1) week prior to this event. Same day move-ups will be permitted, please note it is the handler's responsibility to inform the Trial Secretary before their next event.

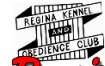

GENERAL AGREEMENT / DISCLOSURE

- Entries must be accompanied by a signed waiver for each dog entered before your dog will be allowed to compete in the CARO trial.

I (we) agree that the club hosting this event, The Regina Kennel and Obedience Club (RKOC), has the right to refuse this entry for cause, which the organizing committee shall deem as sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog participate or be judged, I (we) agree to hold the organizing committee, the organization which it represents, including its members, officers and directors, owners of the premises upon which the event is being held and their employees, harmless from any claim or loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the premises, grounds, or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claims; and I (we) further agree to hold the aforementioned parties harmless from any claim for the loss of this dog by disappearance, theft, death, or otherwise, and from any claim for damage or injury, be caused or alleged to be caused by the negligence of the parties aforementioned, or by the negligence of any other person or any other cause or causes. I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting from injury sustained by any person or persons, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in this event, howsoever such injuries, death or damage to property may be caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.

I (we) further acknowledge that that I (we) have read, understand, and will abide by the Official Rules and Regulations of the Canadian Association of Rally Obedience (CARO) and the provisions for entry as set forth in the Rally Test Schedule of which this entry form is part. I (we) acknowledge and represent that the information supplied by me (us) herein is correct to the best of my (our) knowledge; if any portion of this information is found to be invalid or insufficient to establish the validity of my (our) entry, such findings shall render my (our) entry invalid in its entirety, for which there shall be no refund of fees paid.

Further, I (we) represent that I am (we are) the owner(s) of the dog listed hereon, or that I am (we are) a family member of the dog's owner as stated and allowed in the CARO rules, and that I (we) shall hold the hosting club, Regina Kennel and Obedience Club (RKOC), and CARO, including their officers, directors, employees, and agents and their spouses, harmless from any liability or claim made by the dog's owner(s).
