THE VETERAN SWEEPSTAKES SPECTACULAR IS OPEN TO ALL DOGS SEVEN YEARS OF AGE AND OVER AS OF MAY 5, 2012. ALL ENTRANTS MUST BE ENTERED IN A REGULAR CLASS OR FOR EXHIBITION ONLY ON SATURDAY MAY 5, 2012. ALTERED MALES AND FEMALES ARE ELIGIBLE TO ENTER.

CLASSIFICATION:

MALES 7-9 YEARS
MALES 10 YEARS AND OVER

FEMALES 7-9 YEARS
FEMALES 10 YEARS AND OVER

FINAL JUDGING: THE FIRST PLACE WINNER FROM EACH CLASS WILL ADVANCE TO THE FINAL JUDGING OF BEST VETERAN IN THE SWEEPSTAKES SPECTACULAR AND RESERVE VETERAN

PRIZES:

FOURTH	ROSETTE AND 10% OF TOTAL ENTRY

EXTRACTS FROM CKC DOG SHOW RULES

CHAPTER 6.3.3 – JUDGES - A judge officiating at a show held under these rules shall not be subjected to any indignities of any kind during the progress of the show, and it shall be the duty and obligation of the club holding the show to see this rule is effectively enforced.

Section 2.1 - CHAPTER 13 – ENTRIES AND ENTRY FEES

Every dog entered in Championship Shows held under these rules must be registered, have an Event Registration Number, eligible for registration with the CKC or have a CKC Miscellaneous Class Certification number issued by the CKC Chief Registrar. If a dog is not registered individually in the CKC it may be entered at a show, held under these rules, as a "listed" dog, provided

- (a) It is not a Miscellaneous breed
- (b) If born in Canada, is eligible for individual registration
- (c) If foreign born and owned, an Event Registration Number or CKC registration number is obtained from the CKC within 30 days of the first show entered. A listing fee of \$9.45 must accompany the entry of a "listed" dog at a show held under these rules.

Section 7.2: DISHONORED CHEQUES

Tendering of a dishonored cheque or credit card in payment of entry fees shall be considered non-payment of entry fees and is an offense punishable by disciplinary action and cancellation of awards. Clubs may refuse to accept entries from any exhibitors who have been known to tender dishonored cheques in payment of entry fees unless such entries are accompanied by a money order or certified cheque.

Section 1.4 CHAPTER 16 – DISQUALIFICATION

A dog once disqualified for any reason at a Championship show held under these rules cannot again be shown or entered at a show held under these rules unless and until said dog has been reinstated by the CKC. All awards earned by a dog shown in violation of this section will be canceled by the CKC and the owner of said dog is subject to disciplinary action. Note: for any further information on reinstatement refer to Chapter 16, Section 3 of the CKC Dog Show Rules.

CHAPTER 18 – EXHIBITORS AND THEIR DOGS

A show giving club will be held responsible during the show for the conduct of exhibitors and spectators. Any person acting in an abusive or objectionable manner must be removed from the show on complaint to the Show Superintendent.

NON MEMBER PARTICIPATION FEE - (APRIL 2011)

- **A NON MEMBER PARTICIPATION FEE WILL BE CHARGED TO A RESIDENT OF CANADA WHO IS A NON-MEMBER OF THE CKC. THIS FEE WILL MATCH THE EARN FEE**
- **THE NON MEMBER PARTICIPATION FEE IS PAID IN ANY YEAR A TITLE IS EARNED AND COVERS ALL TITLES AND DOGS OWNED BY THAT INDIVIDUAL**
- **IN ORDER FOR THE TITLE TO BE AWARDED, THE NON MEMBER WILL HAVE A CHOICE TO EITHER BECOME A CKC MEMBER OR PAY THE NON MEMBER PARTICIPATION FEE. FAILURE TO COMPLY WITHIN 30 DAYS OF NOTIFICATION WILL RESULT IN THE TITLE BEING WITHHELD AND THE DOG CANNOT BE MOVED UP TO THE NEXT LEVEL**

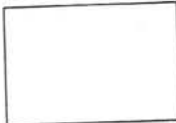

THE DOG MUST BE HANDLED BY THE OWNER, CO-OWNER OR MEMBER OF HIS IMMEDIATE FAMILY. NO LICENSED HANDLER, TRAINER, NOR ANY PERSON WHO HAS PREVIOUSLY HANDLED A DOG THROUGH ITS U.D. (UTILITY DOG) TITLE IN CANADA OR ELSEWHERE, SHALL BE ALLOWED TO COMPETE IN THIS CLASS. A DOG WHICH HAS WON A COMPARABLE DEGREE IN ANY FOREIGN COUNTRY IS NOT ELIGIBLE FOR ENTRY IN THIS CLASS.

NOVICE "B" - FOR ANY PUREBRED DOG THAT HAS NOT WON THE TITLE CD (COMPANION DOG) IN CANADA. DOGS IN THIS CLASS MAY BE HANDLED BY ANY PERSON. MORE THAN ONE DOG MAY BE ENTERED BY ANY HANDLER, BUT EACH DOG MUST HAVE A SEPARATE HANDLER FOR THE "SIT" AND "DOWN" EXERCISES. A DOG WHICH HAS WON A COMPARABLE DEGREE IN ANY FOREIGN COUNTRY IS ELIGIBLE FOR ENTRY IN THIS CLASS.

OPEN "A" - FOR ANY PUREBRED DOG THAT HAS WON THE TITLE OF C.D. IN CANADA, BUT THAT HAS NOT WON THE TITLE OF C.D.X. (COMPANION DOG EXCELLENT). ONLY ONE DOG MAY BE ENTERED IN THIS CLASS BY ANY ONE EXHIBITOR. THE DOG MUST BE HANDLED BY THE OWNER, CO-OWNER OR MEMBER OF HIS IMMEDIATE FAMILY. NO LICENSED HANDLER, TRAINER, NOR ANY PERSON WHO HAS PREVIOUSLY HANDLED A DOG THROUGH ITS U.D. (UTILITY DOG) TITLE IN CANADA OR ELSEWHERE SHALL BE ALLOWED TO COMPETE IN THIS CLASS. A DOG WHICH HAS WON A COMPARABLE DEGREE IN ANY FOREIGN COUNTRY IS NOT ELIGIBLE FOR ENTRY IN THIS CLASS.

OPEN "B" - FOR ANY PUREBRED DOG THAT HAS WON THE TITLE OF C.D. IN CANADA. DOGS IN THIS CLASS MAY BE HANDLED BY ANY PERSON. MORE THAN ONE DOG MAY BE ENTERED BY ANY HANDLER, BUT EACH DOG MUST HAVE A SEPARATE HANDLER FOR THE "SIT" AND "DOWN" EXERCISES. NO DOG MAY BE ENTERED IN BOTH OPEN A AND OPEN B AT ANY ONE TRIAL. A DOG THAT HAS WON THE TITLE OF C.D.X. MUST COMPETE IN OPEN B. DOGS THAT HAVE WON THE TITLE OF U.D. MAY ENTER THIS CLASS. A DOG ELIGIBLE FOR ENTRY IN THE UTILITY CLASS IS ALSO ELIGIBLE FOR ENTRY IN THE OPEN B CLASS AT THE SAME TRIAL.

UTILITY "A" - FOR ANY PUREBRED DOG THAT HAS NOT EARNED THE TITLE OF UD. NO PERSON WHO HAS EARNED A MATCH TITLE MAY HANDLE DOGS IN THIS CLASS. THE HANDLER OF ANY DOG IN THIS CLASS MUST BE THE OWNER OR A MEMBER OF THEIR IMMEDIATE FAMILIES. EXERCISES WILL BE PERFORMED IN THE USUAL ORDER.
