NOVICE STAKE

A Novice Stake at a Spaniel Field Trial shall be for dogs at least 6 months of age on the day of the trial (with no age limit) that have not placed in an All-Age Stake or received placements in any Regular Official Stake (Puppy Stake excepted), at an approved trial in Canada or any equivalent Spaniel trial in any other country. & regulation, Chapter 10.7.1 «Dogs running in Novice Stake must be owned by an amateur and handled by an amateur». (CKC Field trial rules 10.5.3)

PUPPY STAKE:

«A Puppy Stake at a Spaniel Field Trial shall be for dogs at least 6 months of age and under 2 years of age on the day of the trial at which the Puppy Stake is judged.» (CKC field trial rules & regulations, Chapter 10.2)

LIMIT STAKE:

«A Limit Stake at a Spaniel Field Trial shall be for dogs that have not placed in an Open All-Age Stake, or received 2 first placements in any Regular Official Stake (Puppy Stake excepted), at an approved trial in Canada or any equivalent Spaniel trial in any other country» (CKC field trial rules & regulations, Chapter 10.3)

OPEN ALL-AGE STAKE:

«An Open All-Age Stake at a Spaniel Field Trial shall be for all dogs at least 6 months off age, on the day of trial at which the stake is judge». (CKC Field trial rules & regulation, Chapter 10.4)

AMATEUR ALL-AGE STAKE:

«An Amateur All-Age Stake at a Spaniel Field Trial shall be for dogs at least 6 months off age, on the day of trial at which the stake is judge». (CKC Field trial rules & regulation, Chapter 10.5.1) – «Dogs running an Amateur Stake must be owned by an amateur and handled by an amateur». (CKC Field trial rules & regulation, Chapter 10.6.1)

POINTS

Championship Points are awarded for placements in the Open All-Age Stake, provided there are eight (8) or more starters:

1st place – 5 points 2nd place – 3 points 3rd place – 2 points 4th place – 1 point

EVENT REGISTRATION NUMBER (ERN):

All dogs that are foreign born and foreign owned require an event registration number (ERN) to enable them to be awarded titles by the CKC. Dogs may be entered as “listed”; however, an ERN must be obtained within 30 days of obtaining points, awards or scores to avoid cancellation. Application forms may be obtained from the Field Trial Secretary. See CKC EVENT REGISTRATION NUMBER APPLICATION (ERN) form.

NON-MEMBER PARTICIPATION FEE

- a) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.
- b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.
- c) The Premium List must carry a note stating that "these fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members".

TEMPORARY COMPETITION NUMBER (TNC) replaces Listing fee:

****NEW** Temporary Competition Number (TCN)** The current system of entering events with «listed dogs» is being replaced with TCNs, and will allow dogs to temporarily participate in CKC events while they pursue permanent registration or an Event Registration Number (ERN), which will be required to enter all events with closing dates after March 2, 2020.

A TCN must be obtained before submitting an entry and the same TCN must be used for all event entries for a dog until it is permanently registered with either a CKC number or an ERN. The TCN fee is \$12.00 per trial (i.e. per dog, per day).

To obtain a TCN:

First check the dog's profile on CKC to determine if CKC has already created a TCN for it.

If not:

- 1) Go to the CKC web site, click on forms, under Shows and Trials click Exhibitors. Find the Temporary-Competition-Number-Application Form. Complete the application form on line and the TCN should be issued instantly, or:

There is no fee to obtain a TCN, however Exhibitors will still be required to pay TCN fees (formerly called listing fees) when entering events using this number. The current TCN fee is \$12.00 CDN per trial.

INDIGNITIES AND UNSPORTSMANLIKE CONDUCT:

CKC Sporting Spaniel Field Trial Rules and Regulations: 21.7

It shall be the duty and obligation of the trial-giving club to see that a judge, club official, field trial marshal, volunteer, gunner or competitor at a field trial held under these regulations, is not subject to indignities of any kind. The Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue. 7.1 It shall be deemed unsportsmanlike conduct if a person during the running of or in connection with an event abuses or harasses a judge, trial official or any other person present in any capacity at the event. 7.2 Any handler who displays unsportsmanlike conduct or who is seen to kick, strike or otherwise roughly manhandle a dog while on the grounds of a Spaniel field trial at any time during the holding of the event, may be expelled from the trial by the Spaniel Field Trial Committee.

- The Club de Chiens de Chasse de Québec and Quebec's Provincial laws **REQUIRE THAT ALL THOSE IN THE FIELD WEAR A BLAZE ORANGE VEST** (CKC Sporting Spaniel Field Trial Rules & Regulations Chap. 17 Sec. 1).
- **ATVs are permitted to circulate on trial course/ground behind gallery but MUST TURN THE MOTOR OFF WHILE DOGS ARE RUNNING.**
- **Chuckars** (live full winged gamebirds) will be used for Open and Amateur All-Age Stakes.
- **Chukars or pigeons or both** (live full winged gamebirds) will be used for Limit Stake.
- **There will be no water tests.**
- **Lunch service** will **NOT** be available at the field trial site and there will be no banquet due to COVID19
- The consumption of **alcoholic beverages** in the field and on the property is strictly prohibited.
- The Club de Chiens de Chasse de Québec is a member of the Canadian National Spaniel Field Trial Association. All dogs earning points in this trial are eligible to enter the Canadian National Open Championship for the next two years.

RISK

Since the field trial ground of Ste-Anne-de-la-Pérade is not in a humid / wetlands environment and is not in the hardiness zone of Quebec favorable to hazardous seeds / plants, the Field Trial community therefore considers the **absence of listed plant species**.

Because according to any risk assessment and management process the zero-risk «0» option (theoretical and technical) does not exist, the Field Trial community therefore considers (according to a risk matrix) that **the possible exposure risk is very low (very low risk)**.

CCCQ Spaniel Trial Health and Safety Protocols

Due to the the current provincial health measures the CCCQ will be initiating the following health and safety protocols to be adhered to for their Oct 29, 30 and 31 2021 spaniel field trial. This includes the following:

- 1) Spectators are not permitted. Handlers are to social distance and stay in single file when in queue in the gallery.
- 2) Limit the number of volunteer workers in the field to as few as possible (i.e. one marshal, 2 handlers, 4 gunners, 2 judges,). Maintain social distance and/or wear a mask at all times.
- 3) Judges may send dogs on voice or some other method in lieu of tapping to maintain social distancing.
- 4) Requiring participants / handlers to stay in or near their vehicle or trailers until they are invited to compete at the line to minimize the gallery size as is reasonable.
- 5) Not allowing more than two (5) people to congregate in close physical proximity to enclosed side by side vehicles or trailers.
- 6) No individual groups larger than 5 people while still adhering to social distancing.
- 7) Wear a mask where social distancing is not possible.
- 8) No awards ceremony - placements and call backs will be announced via radio and social media (Facebook)
- 9) Bring your own lunch, no kitchen facilities will be provided.
- 10) Hand sanitizer and cleaning wipes will be provided in and close to the outdoor toilet.

All participants must each day evaluate themselves for the following

- 1) Fever or cough in the last 3 weeks that has prevented them from working per their corporate occupational health requirements.
- 2) Quarantined by a health care provider in the 21 days.
- 3) Current cough or fever or any other symptoms of a viral infection.

Any participant having any of the above will not be allowed to participate or be present at the field trial and are asked to voluntarily adhere to this request and leave the trial grounds. Entry fees will be reimbursed accordingly.
