Non-Regular: Wildcard Novice and Open

- \* **ASCA**® (Australian Shepherd Club of America) Obedience is open to all breeds **and mixed breeds**. To earn ASCA titles/legs, a non-ASCA-registered dog needs an ASCA Tracking Number which costs \$10 (Lifetime number), plus \$10 for the owner's Service Membership. (ie. for multiple dogs: \$20.00 total for first dog and \$10 for each additional dog). The Service Membership does not have to be renewed.
- The **Tracking Number/Service Member Application** form is available on the ASCA website at: [www.asca.org/Portals/0/trackapp.pdf](http://www.asca.org/Portals/0/trackapp.pdf). We will also have forms available at CDC and we can send in your application for you, with the trial results package. ☺  
If your dog already has a Tracking Number (from last year or prior) please be sure to bring it with you.
- No entry shall be accepted from a dog or handler disqualified from ASCA programs or a person not in good standing with ASCA.
