As per the B.C. Provincial Health authority notice issued August 23 2021 and effective Sep 13 2021, it is mandatory that all attendees and employees will be vaccinated. There are no exemptions to this. Proof of vaccination may be by official card or QR code downloaded to your phone or e-device or a paper copy. This will be cross checked against official photo I.D. This applies to residents and non residents alike, over the age of 12 years.

Process: When accessing either Hall 1 or Hall 2 every person will provide proof of vaccination. A wrist-band will be issued and worn immediately and visible on the left wrist. You may not take a wrist band and leave. A replacement will only be issued if you return the damaged wristband. Access will be denied for non-compliance. It must be on the left wrist!! Show officials will be requesting to see your wrist band and it must be produced.

Masks are required inside the building at all times except for food and beverage consumption.

These regulations are subject to change. The clubs and their members will act within the rules and guidelines from the B.C.P.H.A. If all parties do not operate within compliance it jeopardizes all future events.

6.9 Moving Up

6.9.1 A dog that is registered in the records of the CKC with an eligible number according to these rules and has fulfilled the requirements for a title in accordance with these rules may be moved to the next level of competition if the schedule permits. The transfer must be on the appropriate move-up form and submitted to the Trial Secretary by the owner or handler at least 15 minutes before the start of the class.
