It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Agility Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit, on receipt of a report indicating that this has occurred.

Affective January 1st, 2011, CKC has implemented a Non-Member Participation Fee of \$57.60 + HST. This fee only applies to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

Entries open 60 days prior to each trial at 12:00 pm and close 10 days prior to each trial at 9:00 pm. Please consult trial dates below to determine proper opening & closing dates. Same day entries will be taken. All entries received after closing will have \$5.00 service fee applied per dog.

Judges & Classes: We will offer <u>1 fun run</u> (judge's choice) prior to start of trial & 3 official classes.

Entry Fees:

Cost is \$23.50 per run. October trial package=3 runs for \$60.00 November trial package=2 runs for \$42.00. Practice round =\$10 Listing fee, per dog per trial \$9.61 (payable ONLY if no CKC registration #, ERN or PEN is available for the dog) Please note: each agility entry includes a \$5.09 CKC Recording Fee where the total trial entry is 125 or under or \$6.55 Recording Fee where the total trial entry is 126 or over.

The Trial Secretary is in full charge of the Trials. Trial precincts consist of the trial building. Whistles, flexis and prong collars are NOT permitted in the building. Please no food, toys or clickers near the ring. Bitches in season are NOT permitted anywhere on the trial grounds. Ring is Top Dog rubber agility flooring with underlay. Ring dimensions are 100 ft x 90 ft x NO OUTDOOR SHOES ARE ALLOWED IN THE BUILDING. Handlers in all classes may walk the course without their dog prior to the start of their class. There will be NO obstacle familiarization. Obstacles shall meet the specifications in the CKC Agility Rules & Regulations effective January 1st, 2014.

To be eligible to compete in these trials, a dog must be 18 months of age and eligible for a registration with the CKC, have an ERN or CKC Misc. Certificate or a CKC Performance Event Number. Spayed bitches, debarked dogs and neutered males are eligible to compete.

Mixed breed dogs may enter these trials with a CKC Canine Companion Number.

Bitches in season may not compete. When a bitch comes into season after the entry has closed, a Vet's certificate certifying the bitch was in season within a 10-day period preceding the trials must reach the trial secretary on or before the start of the first trial. A full refund of entry & listing fees will be given. Online entry fees will not be refunded.

Unfortunately we can NOT refund entries after closing for any other reason. Anyone wishing to pull their entries after closing may upon request receive a 50% credit toward future SPD entry fees for another trial held within twelve (12) months of this trial. This excludes online entry fees if applicable.

No entries will be accepted, altered, cancelled or substituted after the official closing date and time for entries, except as provided in the rules. Exhibitors must abide by errors made in entering their dogs regardless of how and by whom the errors were made.

Entries will be accepted only if accompanied by the correct fees. Courier entries will be accepted if no signature required. Tendering of an NSF cheque is considered non-payment of fees and is punishable by disciplinary action. A \$40 NSF service charge will be applied.

Move ups will be allowed if received 1 hour prior to the trial starting.

Café service will NOT be open at these trials unless noted in each judging schedule.

Flat carded & stringed ribbons will be awarded for qualifying scores & 1st through 4th placements. New title rosettes are available for purchase at our cost of \$6.00 each.

Foreign Exhibitors please note that fees are due and payable in Canadian dollars. Due to fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, in US funds. Please do not mark personal cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated. Thank you.
