Set-up is at 6 pm on Friday, August 3rd. All are welcome to set-up but please note that the rings and general show design must be set-up first before exhibitors claim their spaces.

The Official Show Photographer is Mr. Ron Drake. Please respect the photographer's property. Only the official photographer is to take photographs in the photography booth space.

The Avalon Kennel Club and The Junior Handling Association will jointly run the Canteen at the Shows and Trials. Please support them by donating an item or two and purchasing from the canteen throughout the weekend.

Once again, the BEST PIGGY AWARD is up for the taking. We have been unable to present this award since its inception as no one wants to be a PIGGY !!! Look out !!! We are always watching for the most deserving of the title at the shows and trials. Clean up your grooming area each day please.

GENERAL INFORMATION

- On the day of the show/trial, the show/trial superintendent will be in complete charge of the show/trial.
- Receipts must be presented at the entrance of the show/trial premises. Only dogs properly entered in the show/trial will be admitted.
- The building will be opened 1 (one) hour before the start of the show/trial.
- Dogs may be removed from the building when not required for further judging.
- Dogs <u>must not</u> be left in the building overnight.
- Judging will proceed without any dog not present when called by the ring steward.
- The show/trial committee will use due care and diligence for the welfare of the dogs and the exhibitors, but will not be responsible for, or assume any liability, in the event of an accident or other misfortune to either dogs, exhibitors or patrons.
- If because of riot, civil disturbance, or other acts beyond the control of the management, it is impossible to open or complete the show/trial, no refund of entry fees will be made.
- We regret that trailer hook ups <u>will not</u> be available at the show/trial site.
- It shall be the duty and obligation of the show giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities. The Conformation Show Committee Chair shall promptly report to the CKC any infringement of this regulation. The Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
- The show/trial grounds are defined as the confines of The Goulds Arena (Main Road, St. John's, NL.)
- The authorities of the shows/trials may decline to accept entries for just cause, and/or refuse to receive or may remove any dog from the show/trial building on account of viciousness or disease.
- This is NO SMOKING permitted in or around this venue.
- ✤ IT IS YOUR RESPONSIBILITY TO PICK UP AFTER YOUR DOG. IF YOU CAN IDENTIFY AN EXHIBITOR NOT CLEANING UP AFTER THEIR DOG, PLEASE NOTIFY THE SHOW/TRIAL SECRETARY OR SUPERINTENDENT IMMEDIATELY AND THAT EXHIBITOR WILL BE ASKED TO PROCEED OUTSIDE IMMEDIATELY AND CLEAN UP AFTER THEIR DOG. THERE IS NO EXCUSE NOT TO CLEAN UP AFTER YOUR DOG. POOP BAGS WILL BE PROVIDED AT THE ENTRANCE FOR THIS PURPOSE.
