A dog should not be touched without the permission of the owner or handler.

ON-SITE CANTEEN

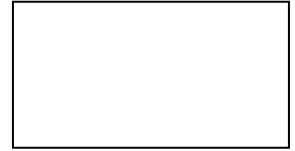
Lunch, snacks and drinks will be available for purchase in the COKC building.
