This means that to take advantage of this offer, your entry must be in the hands of the Trial Secretary (with payment), <u>no later than 10 PM Wednesday</u>, <u>September 14th, 2022</u>. Entries arriving later will be required to pay the Regular Entry Fee.

ENTRY FEES

The Entry Fees may be paid by: cash, cheque (payable to The Moncton Kennel Club) or e-transfer (email: <u>monctonkennelclub@gmail.com</u>). **PLEASE** write "AGILITY" in the comments if you send an e-transfer and indicate for WHO (if the account is not in the handler's name).

* LISTING FEES are payable with the entry for dogs that do not have their individual CKC Registration Number or CKC Event Number (ERN). Official CKC Entry Forms MUST be used.

No post-dated cheques will be accepted. A post-dated cheque is one that is dated after the receipt of the entry. ALL NSF cheques will be subject to a charge of \$25. NSF cheques are considered non-payment of entry fee and are punishable by disciplinary action and cancellation of awards. All fees must be paid before the Agility Trials.

ATTENTION FOREIGN EXHIBITORS

Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted; however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation are appreciated. Thank You.

NON-MEMBER PARTICIPATION FEE

A non-member participation fee will be charged to a resident of Canada who is a "non-member" of the CKC. The nonmember participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual. For the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level. The fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

REFUND INFORMATION

When a bitch comes into season after entry has been submitted to the Trial Secretary, a Veterinarian's certificate, certifying the bitch was in season within the 10 day period preceding the trial, must reach the Trial Secretary on or before the start of the trial.

If a dog is injured after entry has been submitted to the Trial Secretary, a Veterinarian's certificate, certifying the dog was injured before a 3 day period preceding the trial, must reach the Trial Secretary on or before the start of the trial.

No dog may be brought onto the grounds or premises of a trial if it has recovered from distemper, parvovirus, kennel cough or other communicable disease within the last <u>30 days</u>.

ELIGIBILITY

Every dog entered in an approved agility trial or sanctioned agility match must be one of the following: (a) registered with the CKC; (b) have a Canine Companion Number; (c) have an Event Registration Number; (d) have a Performance Event Number; (e) eligible for registration with the CKC or; (f) have a Miscellaneous Certification Number (MCN) if it belongs to a CKC listed breed; (g) have a Temporary Competition Number (TCN).

To be eligible to compete at approved agility trials or sanctioned agility matches a dog must meet the requirements as outlined in these rules, and: (a) must be at least 18 months of age to participate in approved trials, 12 months of age for sanctioned matches; (b) may be spayed, neutered, or debarked; (c) may not be lame (it is the judge's responsibility to determine whether a dog is lame); (d) may not compete if it has tape or bandages (such a dog must be immediately excused and under no circumstances may it be returned later for judging after the tape or bandages have been removed).

Jumps and Tunnels – One level for all dogs

Regular JWW –	Novice, Intermediate, Excellent, Master Excellent

MOVING UP

A dog that has received 3 qualifying scores from at least 2 different judges, may be transferred to the next level provided that a written or electronic request is received prior to the commencement of each trial. Please see the Trial Secretary immediately following the completion of the trial in question for the "move-up form".

TRIAL RULES AND REGULATIONS

Exhibitors are expected to know the CKC Agility Rules and Regulations. There will be a copy available ON SITE, but you can either print off your own copy online (<u>https://www.ckc.ca/en/Files/Forms/Shows-Trials/Event-Rules-</u><u>Regulations/Agility-Rules-and-Regulations-Effective-January-en</u>) or contact the CKC directly and have them mail you a copy for a fee.

PRIZES

Rosettes will be awarded for all QUALIFYING SCORES. Flat ribbons will be awarded for placings in each class.

TRIAL SITE RULES AND FOOD

- **1.** Exhibitors are responsible for cleaning up after their dog(s).
- **2.** There will be NO indoor crating. There are a few large sheltered box stalls along the side of the arena. These will be available on a first come, first served basis.

- 1. Dogs should be ready to run when called. We would like to keep the Agility Trial running smoothly. Please advise the Trial Secretary if your dog is unable to run.
- Exhibitors must abide by any errors made when entering their dog(s), regardless of how or who made the error(s). PLEASE PRINT OR TYPE YOUR ENTRY CLEARLY AND PLEASE CHECK IT BEFORE EMAILING.
- 3. The committee reserves the right to refuse any entry, subject to CKC rules.
- 4. The Trial Superintendent will be in full charge of these events, which are governed by CKC rules.
- 5. Any dog not entered in the Agility Trials will NOT be allowed within the precincts of the event.
- 6. The trial committee will use care and diligence for the welfare of the dogs and exhibitors, but will not be responsible for, or assume any liability in the event of an accident or other misfortune to dogs, volunteer, or patrons. The Moncton Kennel Club will NOT be responsible for any equipment left behind.
- 7. It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Agility Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit, on receipt of a report indicating that this has occurred.
