Telephone and Telegraph entries are prohibited except in such circumstances as the Board of Directors of the CKC may otherwise authorize. **Fax/on line entries** and/or credit card payment will be accepted when accompanied by authorized VISA or MASTERCARD credit card number, expiry date and cardholder's name. \$3.00 per dog per show will be added for FAX/Credit Card entries. OFFICIAL CONFORMATION CLASSES

JUNIOR PUPPY – for dogs 6 months of age and under 9 months of age on the day of the show

SENIOR PUPPY – for dogs 9 months of age and under 12 months of age on the day of the show

12-18 MONTHS – for dogs 12 months of age and under 18 months of age on the day of the show

CANADIAN BRED – for dogs born in Canada. Champions of any other country are excluded

BRED BY EXHIBITOR – for dogs owned and handled in the ring by the breeder. The handler must be the Owner/Co-Owner and breeder/Co-Breeder of the dog. The Owner/Breeder **MUST** handle the dog in this class, but need not handle the dog for further awards

OPEN – for all dogs

VETERAN – for all dogs over the age of 7 years as of the date of the show. Dogs entered in this class may be spayed or neutered.

SPECIALS ONLY – for dogs which have a recorded CKC Registration or Event Registration number and have attained the required points for Championship status. All awards earned at the show will be cancelled if it is found that a dog is not registered or has not completed the requirements for a CKC Championship. Dogs entered in this class will compete for Best of Breed, Best of Opposite Sex and Best Puppy if eligible.

EXHIBITION ONLY – all dogs entered shall be listed in the catalogue with the same particulars as dogs entered in regular competition. Dogs entered in this class may not compete in any regular class but may enter and compete in Non-Regular Classes

NON-REGULAR AND UNOFFICIAL CLASSES

SIRE AND GET is an entry that comprises the Stud Dog and two or more of his get. Ownership in this class need not be identical. Stud dog must be entered in a regular class or in Exhibition Only. Dogs entered in the Stud Dog and Get Class may be spayed/neutered and must be entered in a regular class as outlined in these rules or for exhibition only.

DAM AND PROGENY is an entry that comprises the Brood Bitch and two or more of her progeny. Ownership in this class need not be identical. Brood Bitch must be entered in a regular class or in Exhibition Only. Dogs entered in the Dam And Progeny Class may be spayed/neutered and must be entered in a regular class as outlined in these rules or for exhibition only.

BRACE – is a class that shall be for two dogs of the same breed (not necessarily of the same sex) and identical ownership. Class shall be judged after Best of Breed.

PARADES – Champions, Titleholders, All Poodles. Dogs entered in the Parades **MUST** be entered in a regular class at this Specialty or for EXHIBITION ONLY. ALTERED CLASSES

Are open to Poodles of all Varieties of either sex, over 6 months of age on October, 7, 2011 which have been sexually altered by veterinarian procedure. Altered dog Championship points will be awarded as per Section 15. See note above – MUST be in a regulation trim

EXTRACTS FROM THE CONFORMATION SHOW RULES & REGULATIONS

JUDGES – SECTION 4.1.3

A judge officiating at a show held under these rules shall not be subjected to any indignities of any kind during the progress of the show. It shall be the duty and obligation of the club holding the show to see this rule is effectively carried out.

SHOW OFFICIALS – SECTION 5.1.5

A show-giving club will be held responsible during the show for the conduct of exhibitors and spectators. Any person acting in an abusive or objectionable manner must be removed from the show on complaint to the Show Superintendent.

ENTRY FORMS – SECTION 8.2.3

Entry forms received by the CKC, which are incomplete and/or contain incorrect information may result in awards being cancelled.

ENTRY FORMS – SECTION 8.2.5

An error in an age-specified class, the class, date of birth or sex may be amended on the entry form up to one hour before the start of the show.

ENTRIES - SECTION 8.3.1

Every dog entered in a conformation show must be one of the following:

- a. registered with the CKC
- b. have an Event Registration Number
- c. eligible for registration with the CKC, or
- d. if it belongs to a listed breed, it must have a Miscellaneous Certification Number (MCN)

REFUSAL OF ENTRIES – SECTION 8.6.2

A Club may refuse any entry form from an exhibitor known to have tendered a dishonoured cheque or declined credit card unless entries are accompanied by cash, money order or certified cheque.

DISQUALIFICATIONS – SECTION 14.1.4

Once a dog has been disqualified for any reason at a conformation show, it may not be entered or shown at another show until the dog has been reinstated by the CKC. All awards earned by the dog shown in violation of this section will be cancelled by the CKC and the owner of the dog is subject to disciplinary action.

Non-member participation fee

- a) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.
- b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.
- c) These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members."

RULES GOVERNING THESE SHOWS AND TRIALS

1. THE CLUB RESERVES THE RIGHT TO REMOVE ANY PERSON FROM THE SHOW. THE SHOW SUPERINTENDENT SHALL HAVE FULL CONTROL OF THESE SHOWS AND TRIALS, WHICH WILL BE GOVERNED BY CKC RULES.
2. A DOG EXCUSED BY THE SHOW SUPERINTENDENT OR VETERINARIAN FOR ANY REASON SHALL NOT, COMPETE IN ANY CLASS FOR ANY AWARDS FOR BALANCE OF THE SHOW.
3. THE SHOW COMMITTEE WILL USE DUE CARE AND DILIGENCE FOR THE WELFARE OF DOGS AND EXHIBITORS, BUT WILL NOT BE RESPONSIBLE FOR, OR ASSUME ANY LIABILITY IN THE EVENT OF ACCIDENT OR MISFORTUNE TO EITHER DOGS, EXHIBITORS, SPECTATORS OR VENDORS.
4. DOGS MUST BE ON THE GROUNDS 1-HOUR PRIOR TO THE JUDGING OF THEIR BREED.
5. THE OWNER OF A DOG ENTERED IN THESE SHOWS IS ENTIRELY RESPONSIBLE FOR ANY ERROR IN ENTERING HIS/HER DOG REGARDLESS OF HOW OR BY WHOM ENTRY IS MADE
6. EXHIBITORS AND HANDLERS WILL BE RESPONSIBLE FOR THEIR DOGS AND EQUIPMENT LEFT AT THE SHOW GROUNDS.
7. DOGS TO BE EXERCISED IN DESIGNATED AREAS ONLY, NOT IN VICINITY OF RINGS
8. ALL RECREATIONAL UNITS WILL HAVE BUCKETS UNDERNEATH FOR THEIR SINK DRAINS. ANYONE FOUND DISCHARGING WATER ON THE GROUNDS WILL BE REMOVED BY ORDER OF THE HEALTH DEPARTMENT, AND MAY BE SUBJECT TO A FINE.
9. IF, BECAUSE OF CIVIL DISTURBANCE OR OTHER ACTS BEYOND THE CONTROL OF THE CLUB, IT IS IMPOSSIBLE TO OPEN OR COMPLETE THE SHOW, NO REFUND OF ENTRY.
10. DOGS MUST BE ON LEASH AT ALL TIMES ON THE SHOW GROUNDS OR WITHIN THE SHOW BUILDING WITH THE EXCEPTION OF THE OBEDIENCE RINGS.

In consideration of the acceptance of this entry and of the holding of the Show and of the opportunity to have the dog judged and to win prize money, ribbons or trophies, I (we) agree to hold the Fraser Valley Dog Fanciers, the Poodle Specialty Club of BC and their respective members; directors; governors; officers; agents; superintendents or show secretaries and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of a dog while in or upon the show premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim, and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of a dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of the Club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.
