The Draft Dog Test Chair shall promptly report to the CKC any infringement of this regulation and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.

## DRIVING DIRECTIONS TO TEST SITE:

### 520 Charlotteville Rd. 7, Simcoe, ON

(Note: some GPS units prefer the address to be Norfolk instead of Simcoe)

#### If travelling from the east on Hwy. 401, QEW, or 403

- From the 403, take exit 27 for ON-24 S/Rest Acres Road S toward Simcoe
- Turn right onto Vanessa Rd/Brant County Rd 4 (signs for County Road 4/Vanessa Road/Delhi)
- Merge right onto Church St. E.
- Turn left onto ON-3 E
- Turn right onto Pine Grove Rd/Regional Rd 46 (signs for Regional Road 46/Pine Grove Road)
- Continue onto Charlotteville West Quarter Line
- Turn left onto Charlotteville 7 Rd/Concession Rd 7 (second house on the right after the turn)

#### If travelling from the west on Hwy 401

- take exit 218 for ON-19 S toward Harris Street/County Road 119/Tillsonburg/Ingersoll. Keep right at the fork, follow signs for Tillsonburg and merge onto Plank Line/ON-19 S
- Turn left onto Ostrander Rd/County Rd 19 (signs for Ostrander Road/County Road 19)
- Turn right onto Oxford Rd 13/West Street S/Regional Rd 13
- Turn left onto ON-3 E
- Turn right onto Rhineland Rd/Regional Rd 16 (signs for Regional Road 16/Rhineland Road/Silver Hill) – road becomes Forestry Farm Rd
- Turn left onto Charlotteville Rd 7
- 520 is one concession down on the right hand side (second house past the stop sign)

## General Information and Test Rules:

It is the responsibility of the exhibitor to be familiar with the rules pertaining to the event in which they are competing. Copies of the CKC Draft Test Regulations are available from the Canadian Kennel Club (Tel: 416-675-5511)

As per the Draft Dog Test Rules and Regulations, the group option as stated in section 11.2, may be offered at this test.

To comply with instructions issued by the Canadian Kennel Club, we will be unable to accept any entry reaching the Test Secretary after the official closing date as published in the premium list or after the maximum number of entries has been received. If the maximum number of entries is not received, day of entries will be accepted at a fee of \$85.00

No Entry will be accepted unless all particulars called for on the entry form are shown thereon. Incomplete entries will be returned.

No Entry will be accepted unless accompanied by the entry fee. Telephone, fax and email entries cannot be accepted.

Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entries were made. Cancellations of any entry after the closing day are prohibited.

The Club reserves the right to refuse any entry, subject to CKC Rules.

Identification and judging schedules will be e-mailed as soon as possible after entries close.

**Eligibility:** Open to all purebred CKC recognized & CKC Miscellaneous breed (MCN), and non-recognized dogs eighteen months of age or older on the day of the event. Every dog entered must be one of the following: Registered with the CKC; have an Event Registration Number (ERN); eligible for registration with the CKC; have a Performance Event Number (PEN); or a Canine Companion Number (CCD). Entries in the Draft Dog Excellent Test must have a CKC Draft Dog (DD) Title. Entries in the Brace Draft Dog Excellent Test must have a CKC Brace Draft Dog Title. The Judges must excuse a dog at any time during a test for lack of physical capacity.

**Entry Limit:** There is a limit of a combination of 10 Draft Dogs/10 Brace Draft Dogs and 5 Draft Dog Excellent/5 Brace Draft Dog Excellent entries which will be accepted on a first come, first served basis.

**Entries:** Entries must be complete, signed & submitted on the official CKC entry form. The order of competing shall be the order that entries are received except that dogs handled by the same person will be separated when possible. No delays will be permitted for handlers entering more than one dog and entrants doing so must have an alternate handler available for the group down exercise if a conflict arises. Re-qualifications will be accepted pending space available. Re-qualifications shall be judged as the last team in the section for which they are entered. After the closing date, mail, email, fax and/or telephone of their entry will notify all entries.

**Bitches in Season:** Bitches in season are allowed to compete but all exercises will be judged after all other dogs have been tested. Bitches in season must be kept away from the test site prior to testing.

**Equipment:** Each entrant to supply his or her own equipment and apparatus. The test committee will supply the freight load. DDX Entrants must provide their own backpacks and backpack weight.

**Test Regulations:** All dogs entered in the Draft Dog Test must go through the basic control exercise, regardless of obedience titles held.

**Entries Close: 5:00 p.m. Wednesday, October 7, 2020** or when the limit as outlined on front of this premium list is reached, even if official closing date for entries has not arrived. If combination of DDX/BDDX entries has not been received by the closing date these openings may be filled with additional DD/BDD entries. Entry fees will not be refunded after the closing date. If the limit is reached prior to closing date, a list of alternates will be kept to fill any vacancies created due to early (prior to closing) cancellations. Entry fees will be refunded within 10 days following the Test to all withdrawals replaced by an alternate and to all alternates and re-qualifications that did not participate in the test. Email confirmation of receipt of entry will be provided to entrants who provide a valid, legible email address on their entry form.

**Foreign born/ owned dogs:** A dog not individually registered with the CKC may be entered at a test held under these regulations as a "Listed" dog, provided it has an event registration number (ERN) or obtains this from the CKC within 30 days of the first test entered otherwise scores will be cancelled. **Non-member Participation Fee**

- A non-member participation fee will be charged to a resident of Canada who is a non-member of the CKC.
- The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.
- In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.
- The fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

COVID-19 Procedures for Draft Test

**SOCIAL DISTANCING MUST BE MAINTAINED AT ALL TIMES**

This is not a spectator event and to be able to facilitate social distancing only the entrants, judges and committee members are allowed on the site.

Only park in your designated area. Physical distancing is required between vehicles. There are no tents allowed.

There will be **no** lunch provided – please make sure that you bring your own lunch. Water will be available.

This venue is private property so please make sure that you pick up after your dog. Please make sure you pick up after yourself as well. There will be garbage bins available for your trash.

There will be a port-a-potty available on site – please ensure that you read and follow all instructions for the use of this toilet facility. There will be sanitation guidelines in effect.

Please make sure that you are only at the ring when you are asked to be there by the committee member who is locating the next person on deck.

Once you have completed your exercise in the ring – please return to your set up and wait to be called for the next exercise.

While in the ring it is not a requirement to wear a mask unless you are within 6ft of the judge then masks are mandatory.

Judges will be required to wear masks and gloves (changed with each dog) when inspecting the dog and harness. Handler must also wear a mask.

There will be a bucket available for each handler to place their leash in and they will also retrieve their own leash. The bucket will be sanitized after each dog.

Please make sure that you know your armband number as there will be no catalogue available for viewing. The Secretary will provide you with your armband.

If there are more dogs than can be social distanced during the down stay – the group will be split to accommodate the number of dogs to safely accommodate social distancing.

There will be individual loads for each dog and they will be identified with armband numbers. They will be available to review and will be set out so that there can be social distancing.

There will be hand sanitizer and hand wipes available.

If you see someone who is not following these rules – do not confront them – please advise the Event Secretary.

***The Bernese Mountain Dog Club of South Western Ontario will do everything to ensure that you are safe HOWEVER it will take everyone following the rules and SOCIAL DISTANCING and MASK WEARING to make it happen.***
