Time for Conformation Judging is based on 20-25 dogs per hour.  
Obedience Judging is based on: Utility-6 dogs/hour, Open-7dogs/hour, Novice A, B, C &  
Intermediate-8dogs/hour & Pre-Novice-9 dogs/hour.

Exhibitors are advised to check judge's sheets when posted and to immediately advise of any inaccuracies. It is the exhibitor's responsibility to know the rules pertaining to show and trials.
