Please be at the trial site 30 minutes before the handler's meeting so that we can begin on time. We have a very full schedule for these trials so **please be ready** when it is your turn to run. No dogs or spectators within 10 feet of the arena.

Facility

Our host facility is a working farm. Please keep your dogs on leash at all times and stay away from animals, INCLUDING GUARDIAN DOGS, in the pasture. Keep your dogs crated when not being exercised or in the arena. We will have water and toilet facilities on site; please bring shade for yourself and your dogs. This is Alberta, so come prepared for ALL weather.
