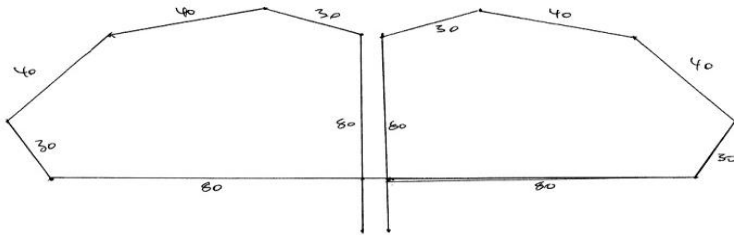


## ELIGIBILITY AND COURSE

The club reserves the right to alter the course plan as required by weather and/or field conditions on the day of event. Course will be reversed for the second event.

**ELIGIBLE BREEDS:** Chase Ability Program participation is open to all purebred and mixed breed dogs at least 12 months of age that are individually registered with the CKC; or have an Event Registration Number (ERN); or have a Performance Event Number (PEN); or eligible for registration with the CKC; or have a Miscellaneous Certificate Number (MCN) if it belongs to a CKC listed breed; or have a Canine Companion Number (CCN) if it's a mixed breed.

Dogs with breed disqualifications are eligible to enter. Females in season may not enter. A dog may enter only once per event. Dogs run as singles.

**300-YARD COURSE:** This distance is for dogs shorter than 12 inches at the withers or brachycephalic ("flat-faced") dogs. **Dogs will run one loop.**

**600-YARD COURSE:** This distance is used for all dogs that do not run the 300 yard course. **Dogs will run both loops.**

If there is a question as to which course a dog will run the judge will decide.

**CONDITIONS:** All dogs will run individually. Bitches in season or lame dogs will be excused and any entry refunded if notice is given prior to roll call. Dogs not present at roll call will be scratched and entry fees not refunded. Handlers must use slip leads when starting their dogs. Muzzles may be used at owner's discretion. All dogs will be slipped from a standing start.

NOTE: CKC rules re NSF cheques – tendering of an NSF cheque shall be considered NONPAYMENT OF ENTRY FEES and is an offense punishable by disciplinary action and cancellation of awards by the Canadian Kennel Club. There will be a \$40.00 charge on all NSF cheques received.

### OTHER ENTRY INFORMATION

1. No entry will be accepted unless all particulars called for on the entry form are completed in full and accompanied by a signed waiver and entry fees. Telephone entries cannot be accepted
2. Cheques dated after the close of entries will not be accepted. Tendering of an NSF cheque will be considered non-payment of entry and can result in cancellation of awards. All NSF/returned cheques are subject to a \$25 service charge. There will be no refund of overpayments or duplicate entries
3. An exhibitor has the right to withdraw an entry up to the closing date and time published in the premium list. Written or electronic notification **MUST** be received by the Event Secretary by the official closing date and time. If written notification is not received by that time, the dog will remain entered in the event(s). Entries that are cancelled before the closing date will be refunded.

**THERE WILL BE A LIMIT OF 50 ENTRIES ACCEPTED PER EVENT**

### RIBBONS

- Rosettes will be awarded for dogs completing the Chase Ability Program title.
- Flat Ribbons for a pass result

## **CHAMPIONSHIP SHALL BE AWARDED ON THE BASIS OF THE FOLLOWING:**

Three titles will be awarded for dogs that pass the Chase Ability Program event the required number of times. For purebred dogs, these are suffix titles that will appear on a dog's pedigree with a higher level title superseding a lower level title.

1. Chase Ability (CA) – Awarded to a dog that passes the Chase Ability event three times under at least two different judges.
2. Chase Ability Excellent (CAX) – Dog pass the CA event a total of 10 times (CA + 7 additional passes)
3. Chase Ability Excellent 2 (CAX2) – Dog passes the CA event a total of 20 times. A higher number title will be awarded for every ten (10) passes.

## **CANADIAN KENNEL CLUB INFORMATION**

### **NON-MEMBER PARTICIPATION FEE POLICY**

Effective January 1, 2011

- a) A non-member participation fee will be charged to a resident of Canada who is a non-member of the CKC. The fee will be \$59.40, plus applicable taxes.
- b) The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.
- c) In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld.
- d) The fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

### **EVENT REGISTRATION NUMBER (ERN)**

Effective January 1, 1992, all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will no longer require a CKC registration number but will require an Event Registration Number (ERN). This ERN does not register a dog for breeding purposes as defined in the Animal Pedigree Act, but Rather enables a foreign-owned dog to be awarded titles by the Canadian Kennel Club. Each dog must have its own number. To obtain an ERN, mail or fax a photocopy of the dog's foreign registration certificate with a cheque or VISA/MasterCard number (expiry date, cardholder's name and signature). Provide your complete address for return of the ERN to you. Cost is \$59.40, plus taxes.

## **MIXED AND UNRECOGNIZED BREEDS**

These events are open to mixed and unrecognized breeds. In order to compete, mixed and unrecognized breed dogs must have a Canine Companion Number (CCN) from the Canadian Kennel Club and must have a CKC-approved microchip. Mixed-breed dogs must be spayed or neutered. Unrecognized-breed dogs do not need to be spayed or neutered. A dog eligible for a CCN may not be entered as a listed dog.

## **DIRECTIONS, HOTELS, CAMPING**

**Directions:** (GPS 45 04 09.44N 74 16 37.36W)

**From 401:** take exit 750 (Morrisburg), go NORTH (toward Winchester) about 22 km Turn R. onto River Rd. (1st rd. after Cass Bridge; previous Rd. = Nesbitt, also known as airport rd., on R. also); Cass Bridge Cheese (& ice cream!) House is directly opposite River Rd. Go 4 km along River Rd.; there will be a bridge across the river (South Nation) on your R. This is Nation Valley Rd. Take this bridge, keep on curve to the L. 12758 will be the 1st place on R. after that curve. Go past the house (2 story red brick), past the barn, drive on lane way along fence till you see the field.

### **From Ottawa:**

31 south (Bank St.) to 4 km south of Winchester (do not turn into Winchester, stay on 31); turn L. onto River Rd. opposite that cheese house, then as above.

### **From Kemptville:**

Hwy 43 east to 31, turn R onto 31 (south) - then as above.

### **From Alexandria or Monkland:**

Hwy 43 west to Chesterville; just past 1st exit off 43 for Chesterville, Nation Valley Rd. is on the L., Eastern Ontario Graphics on SE corner. 12758 is about 5 km down, on the L.

### **ATTENTION ALL EXHIBITORS:**

#### **FIELD CONDITIONS**

No shade on field or camping area. All fenced, well away from roads.

Water tub will be available for dogs.

**Grass will be farm length** (cut or grazed down, not mown to golf course length); there will be sheep manure on the field. Very flat

**PLEASE TAKE YOUR GARBAGE WITH YOU** – This is the first trial where you are encouraged to not pick up your dog poop – please walk your dogs at the edges of the field so nobody steps in it.

#### **ADDITIONAL INFORMATION**

- Port-a-potty on site
- Dogs will run once per event
- Lame dogs or bitches in season will be excused and their entry fees refunded provided notice is given prior to or during roll call
- Dogs not present at roll call shall be scratched with no refunds. NO exceptions
- Dogs are expected to be aroused and excited in the presence of the lure, but handlers must be able to control their dogs for everyone's safety or they shall be refunded their entry and not allowed to run. Additionally, the field committee reserves the right to bar known aggressive dogs from the event site
- Flexi Leads and Electronic Collars are not permitted on the field
- BCO appreciates everyone's co-operation in keeping our site clean.
- There will be a \$10.00 fine for any loose dog interfering with a course in progress.
