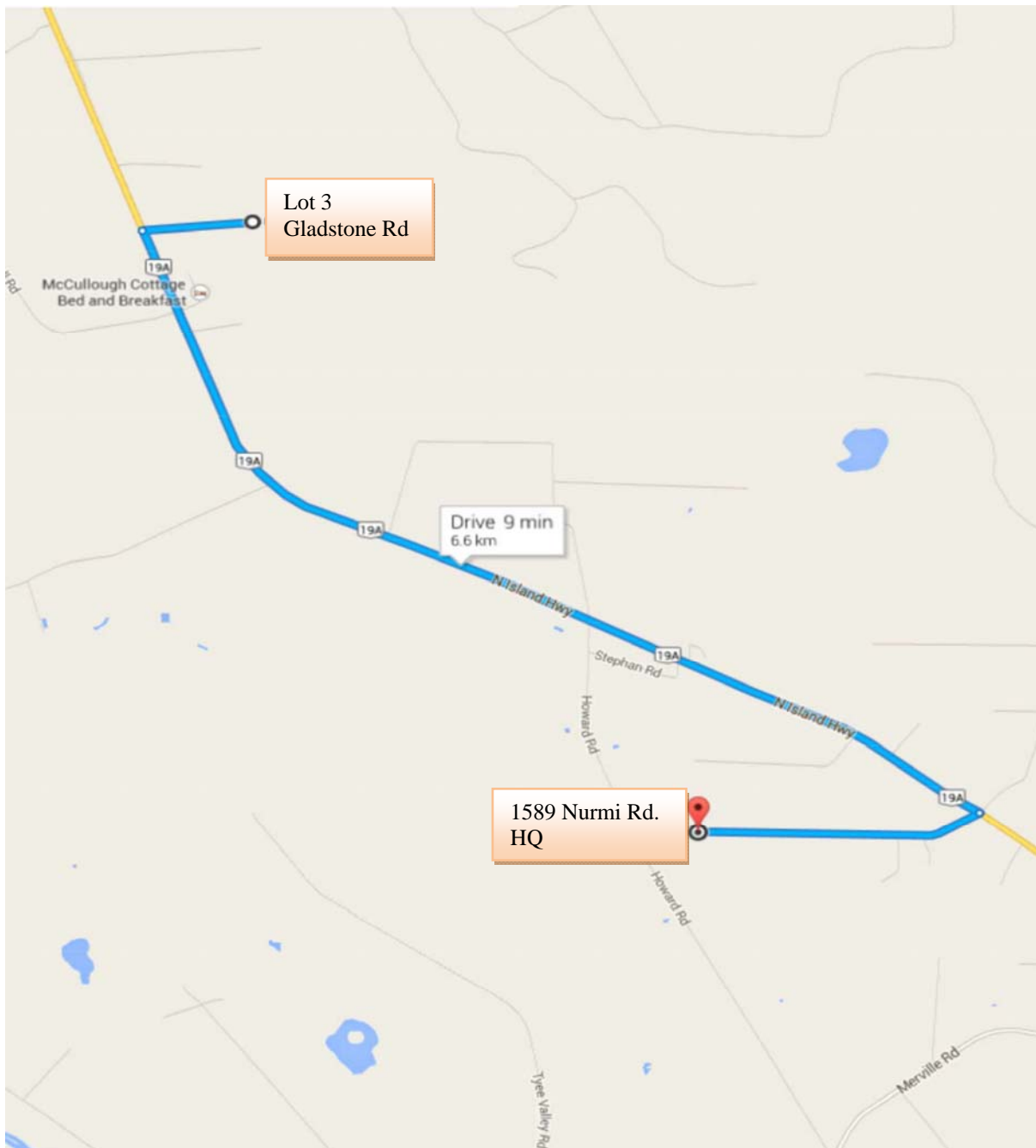
### GENERAL INFORMATION - MUST READ

- **Rules:** Working Certificate Test Rules and Regulations Books are available from the Canadian Kennel Club, 100 - 89 Skyway Ave., Etobicoke, ON M9W 6R4
- **Listing Fee:** If you do not have a CKC Registration, ERN or PEN number- A \$9.40 (including PST/GST) listing fee as established by the CKC must accompany the entry of a dog for which a CKC individual registration, Event Registration Number (ERN) or Performance Event Number (PEN) is not shown on the entry form.

- **Canadian Resident Non-CKC Member:** If you are a Canadian resident and not a CKC member please read the [CKC Non-Member Participation Fee](#) policy (effective January, 1<sup>st</sup>, 2011)
- **Entries:** Entries must be typewritten or CLEARLY printed, completely filled out and signed. Owners are responsible for errors on entry forms or where hand-writing is not clearly legible. No phone, faxed, emailed, late or day of entries will be accepted. A separate entry for EACH dog in EACH test is required on an official CKC entry form. ERN's (Event Registration Numbers) for foreign born or foreign owned dogs can be obtained from the CKC or Test Headquarters. ERN must be applied for within 30 days of entering a CKC event.
- **Awards:** Official CKC Rosettes will be awarded to all qualifying dogs at the end of the test day.
- **Refunds:** Entry fees will not be refunded after July 28<sup>th</sup>, 2014. In the event that a dog is absent, disqualified, excused by a judge or barred from competition by action of the Test Committee or the Canadian Kennel Club, no refund of entry will be made. Bitches in season are NOT eligible for entry and are not allowed on the test grounds. Bitches may be subject to vetting. Entry and listing fees paid for any dog withdrawn because of estrus, illness or death shall be refunded in full if notification in writing is accompanied by a veterinarian's certificate. All refunds must be requested in writing and once the catalogue has been printed, will be less CKC event fees and listing fees if applicable.
- **Running Order:** Running order will be drawn at the home of the Test Secretary. Males and females will be run in the order of the draw or at the discretion of the Marshall.
- **Start Times:** Start times will be adhered to as strictly as possible and handlers are asked to be at their stake and checked in with their Marshall a minimum of 15 minutes prior to start time regardless of running order.
- **Clothing:** All handlers and spectators shall not wear white or distinctively light clothing at any time but handlers may wear a handling jacket for the WCX blinds.
- **Birds:** Dead ducks, pheasants and/or chukkar partridge may be used in each stake.
- **Grounds:** CKC WC Test Rule Section 10.1.6 – "No training will be allowed on the test grounds within 24 hours of the start of the test. A bumper thrown by a handler for purpose of warm up shall not be considered training." All dogs when not running in their test MUST be on leash and under control. Bring adequate shade, sunscreen, water and cover for hot or rainy weather for both you and your dog(s). Be prepared and carry a first aid kit. YOU MUST pick up after your dog and airing is only allowed in areas designated by Test Headquarters and Test Marshalls. Please respect the landowners that have so graciously allowed us on their land by obeying all signs, removing all garbage and debris. Close all gates behind you and park ONLY in designated areas.
- **Indignities to Judges:** CKC WC Test Rule Section 14.7 – "It shall be the duty and obligation of the event-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities. The Working Certificate Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue."
- **ALL Competitors & Spectators:** BY ATTENDING this test, competitors and spectators acknowledge that the Upper Island Retriever Club, test officials and the Landowners involved do not accept liability for any loss, damage or injury incurred by exhibitors, dogs or spectators.

## WORKING CERTIFICATE TEST HEADQUARTERS & CHECK IN TIMES

- **Check in:** On Saturday Aug 2<sup>nd</sup> please check in at Test Headquarters at Everett Farm at 1589 Nurmi Rd. at least 30 -45 minutes before your test start time to receive your catalogue and instructions. On Sunday Aug 3<sup>rd</sup> please check in with the Test Marshall at Gladstone Farm on Gladstone Rd., at least 15 – 30 minutes before your start time. We ask everyone to drive SLOW on the roads leading to Test Headquarters and Test locations. This is a farming community, watch for children, farm machinery, animals, farm dogs – be aware and obey ALL posted speed limits.
- **Directions to WC Test Headquarters: Saturday August 2<sup>nd</sup>, 2014**  
From Campbell River or Highway 19 Hamm Rd Connector: Travel South on 19A , Turn RIGHT on Nurmi Rd  
From Courtenay: Travel North on 19A, Turn LEFT on Nurmi Rd  
– 1589 is end of Nurmi Rd on the LEFT hand side.
- **Directions to WC Test : Sunday August 3<sup>rd</sup>, 2014**  
From Campbell River or Highway 19 Hamm Rd Connector: Travel South on 19A , Turn LEFT on Gladstone Rd which is two driveways South of the Black Creek Bridge.  
From Courtenay: Travel North on 19A, Turn RIGHT on Gladstone Rd which is about ½ km North of Endall Rd before the Black Creek Bridge.  
Travel appx 1000 meters to the end and Lot 3 property is at the end of Gladstone Rd.
