WITHDRAWAL OF ENTRIES

An Exhibitor has the right to withdraw an entry up to the closing date and time as published in the premium list. This may be done by telephone, however written or electronic (e-mail) notification must be received by the Show Secretary no later than the official closing date and time. If written notification is not received by that time, the dog will remain entered in the show.

NOTE: Owners are responsible for keeping track of their scores and bringing it to the attention of the Show secretary who will confirm the aggregate.

JUNIOR HANDLING (OBEDIENCE)

Junior Handling (Obedience) will be held Saturday and Sunday during the lunch breaks. Entries will be taken 10:00 - 11:00 a.m. on each day. Entry Fee: Free – sponsored by CKC Zone 9 Obedience Representative.

Classes Offered: Pee Wee (non-competitive) / Junior Novice / Intermediate Novice / Senior Novice / Junior Open / Intermediate Open / Senior Open

Age Structure: Pee Wee (4-6 years)/Junior (7-11 years)/Senior (12-18 years)

Held under CKC Rules. Dogs handled in the competition must be entered in the trial on that day.

The SKOC will be offering: Ribbons for placements 1 through 4 in all classes and a Rosette for the Best Overall Junior Handler.

MAT TIME

Friday evening -5:30 - 8:00pm - \$10.00 per dog (10 minute maximum). Sign up at ringside - first come first served.

DAY-OF-TRIAL ENTRIES

Day-of-trial entries will be accepted both February 8 and 9, 2020. Entries must be made at least one hour before the start of the trial. Day-of-trial entries will be cash only.

BENCHING

Is limited. No ex-pens will be allowed.

ADDITIONAL INFORMATION

- The scoop-up requirements will be strictly enforced.
- ◆ There will be **NO "In Transit"** area provided. No dog will be allowed in the building unless entered in the Trials or Exhibition Only.
- ◆ There will be no "overnight" kenneling.
- ◆ Only approved CKC collars will be allowed in the precincts of the trials.
- ♦ SHOWING correct information on the entry form is the responsibility of the entrant. However, Exhibitors incorrectly entered in the "A" class are permitted to move the dog to the corresponding "B" class up to one hour before the start of the trial. The SKOC takes no responsibility for omissions or errors made on the entry forms. The Show Committee reserves the right to refuse any entry subject to the CKC rules.
- ♦ BITCHES IN SEASON: Obedience entry fees WILL be gladly refunded to exhibitors whose females are in season during the trials (and must be withdrawn) IF: a dated veterinarian's certificate is produced prior to the trial.
- ◆ THE PRECINCTS of these trials shall be the Manhattan Ballroom building & grounds.
- ♦ KNOWLEDGE of the Canadian Kennel Club Rules is the responsibility of the entrant. Rule books may be obtained from the CANADIAN KENNEL CLUB, 200 Ronson Drive, Suite 400, ETOBICOKE ON M9W 5Z9, Telephone: 416-675-5511
- ◆ The SKOC will use due care and diligence for the welfare of the dogs and exhibitors but will not be responsible for, or assume any liability in the event of an accident or other misfortune, either to dogs, exhibitors or spectators.
- ◆ All dogs must be under complete control at all times.
- ♦ 20.7 It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer, or competitor at an obedience or rally trial held under these regulations, is not subject to indignities of any kind. The Trial Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.

PLEASE NOTE:

When entering the same dog in multiple classes a separate entry form MUST be filled out for EACH class.

Lunch will be available for purchase between 11:30 am and 1pm each day. Coffee/Beverages and some snacks will be available during trial hours.
