Equipment and Field Conditions: An electric drag will be used (back up: continuous loop). The field is relatively rough hay land. We would appreciate help from exhibitors to fill gopher holes each day.

Entries:

These trials are open to any Afghan Hound, Basenji, Borzoi, Deerhound (Scottish), Greyhound, Ibizan Hound, Irish Wolfhound, Italian Greyhound, Pharaoh Hound, Saluki or Whippet registered or eligible for registration with the Canadian Kennel Club.

Altered or neutered hounds may compete. Hounds presently disqualified under CKC, CSFA, ASFA or AKC rules are not eligible. Hounds must prequalify prior to entering their first trial in Canada.

Stakes:

Open, for all hounds, including Field Champions

(We will also offer a Mixed Stake, combining breeds with entries of three or fewer, if all owners agree.)

Best in Field

Post-Entry: (after Sept. 8, 2015) Includes CKC Recording Fee
\$25.00 per hound per trial

Other Fees:

\$5.00 per entry/stake - All unofficial stakes
\$8.95 CKC listing fee for all non-CKC registered hounds (includes 5%GST)
\$50.00 fee if cheque returned.

Prizes:

Best in Field: Rosette and prize
Best of Breed (official stakes): Rosette and prize
Second through NBQ: flat ribbon
First in each unofficial stake: Prize

Directions to the field: The field is about 4 km southeast of Delisle, at the intersection of Range Road 3082 (Durham Road) and Township Road 342. If you are coming north from Calgary on #7, turn right on #766 just as you are about to leave Delisle, and right at the first turn past the feedlot. The Pattison farm (big red barn, metal roof) is the first place you come to; the field is across the road from the buildings, on the right. If you are coming from Saskatoon on #7, turn left about 10 km past Vanscoy, onto Durham Road. The Pattison farm is the second place you come to (the first is a house very close to the highway).

Additional Information:

Camping is available at the field, but there are no amenities (beyond a portapotty).

There will be a limited food concession available, both days.

Bring your own water. There is no shade on the field.

Stakes will be split if the entry is 24 or more hounds at roll call.

Hounds will be run twice, in braces or trios (except single dog entries) unless excused, dismissed, or declared ineligible.

Lame hounds or bitches in season will be excused and their entry refunded, provided notice is given prior to or during roll call.

Hounds not present at roll call shall be scratched with no refunds. No Exceptions.

All handlers must use a slip lead when releasing a hound. A Standing Start will be used on Tally-Ho.

Leg wrappings must be of a neutral colour to comply with CKC rules. Muzzles and catch collars may be used at the handler's discretion.

A \$5.00 fine will be assessed for loose dogs on the field after roll call and until after Best in Field.

No catalogue will be published. Score sheets will be available.

Please clean up after yourselves and your dogs.

Please come early to help fill gopher holes.

24-12-3. Non-member participation fee

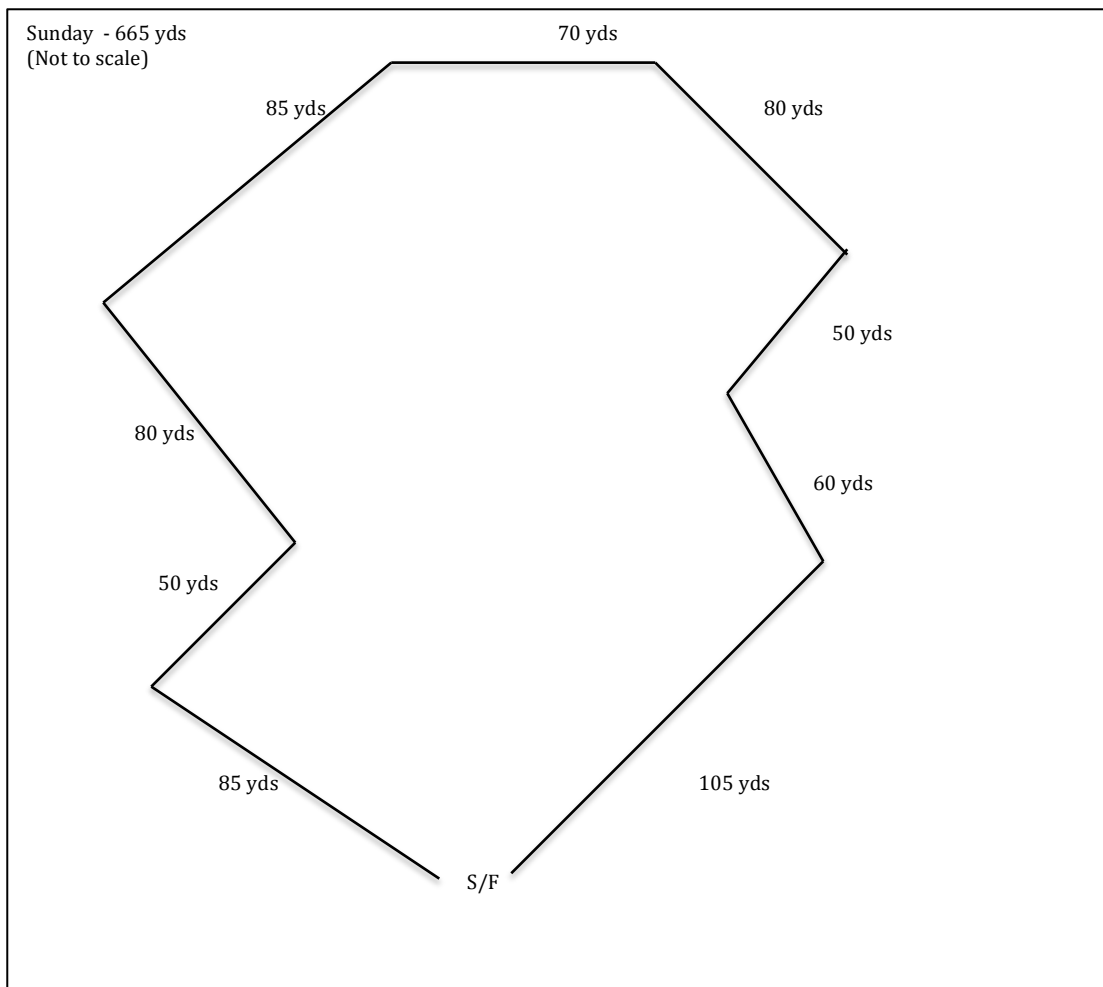
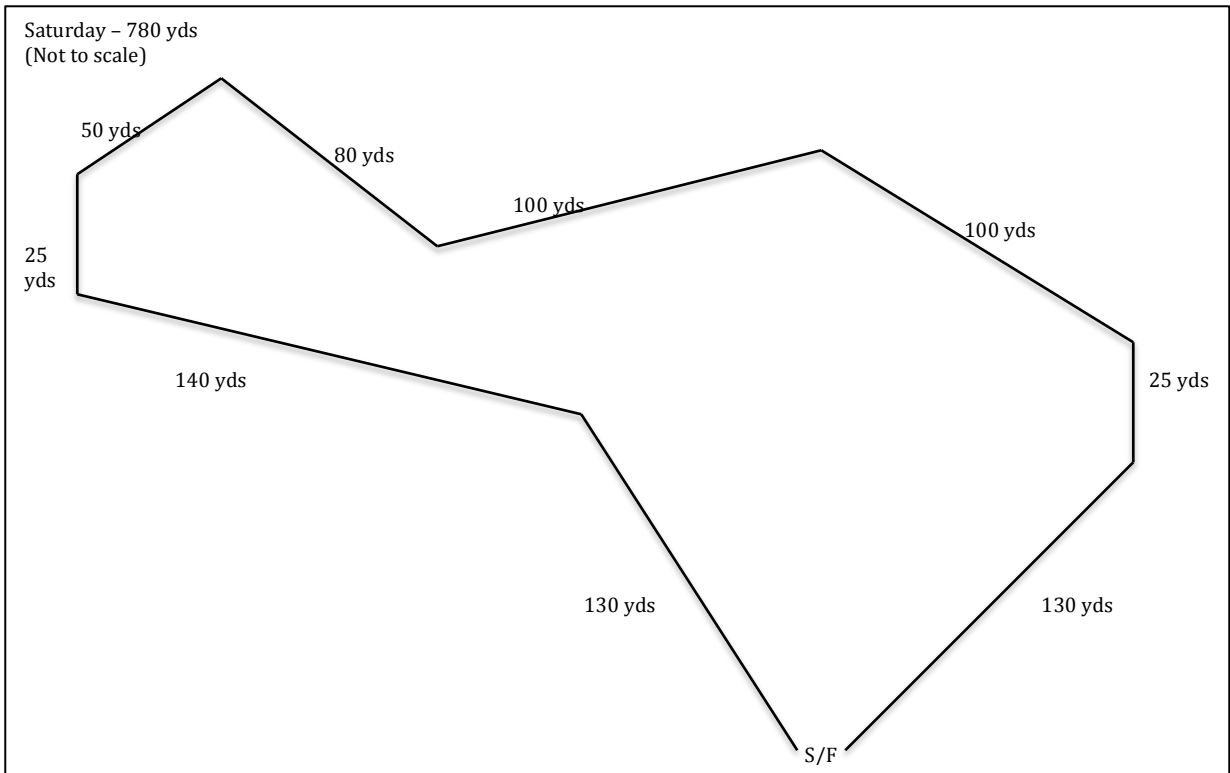
a) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.

b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.

c) The Premium List must carry a note stating that " these fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members."

It is in your best interest to acquire a Basic CKC membership at \$50 + GST to cover all your dogs as opposed to the Non-Member Participation

Fee of \$55+GST per dog.
