The C C Mistral of Waldenridge CGN CD TD AGN RE Perpetual Rally Obedience

Trophy for Highest Scoring SDKC Member (highest single score at the weekend of trials). Donated by Mary-Anne Boulet

Note to Exhibitors: The C C Mistral of Waldenridge CGN CD TD AGN RE Perpetual Rally Obedience Trophy is used for the photograph of the winner & the name of the winner & their dog will be put on the trophy. The trophy remains in the possession of the Sudbury & District Kennel Club throughout the year. The trophy will be awarded to the team achieving the highest score (or in case of a tie – the highest score and the fastest time). Should there be a tie in score AND time, the trophy will be awarded to the lower class (ie should there be a tie between an Advanced B and Advanced A – it will be awarded to the Advanced A. Should there be a tie between an Excellent class team and Novice team, it will be awarded to the Novice team.)

Trial precincts shall consist of the entire hall at 450 RR 55 , Lively, ON.

Moving Up

A dog that is registered in the records of the CKC or has a PEN, an ERN, or a MCN and has fulfilled the requirements for a title in accordance with these rules, may be moved to the next level of competition. The transfer must be submitted to the trial secretary on the appropriate move-up form by the owner or handler **one hour before the trial commences on that day**, schedule permitting.

6.3 Tendering of a NSF cheque in payment of entry fees shall be considered non-payment of entries and is an offence punishable by disciplinary action and cancellation of awards

A service charge of \$35.00CDN will be applied to all returned cheques

All fees are in Canadian funds. USA exhibitors please pay with a postal money order in Canadian funds. Do not send cash in the mail. Cheques that draw on a USA account will be taken at par. Discounted entries will be rejected.

Incomplete entries will be returned. No entry will be accepted unless accompanied by entry fees. Entry fees will not be refunded should a dog be absent, sick, lame or excused by a Veterinarian, Judge or Trial Superintendent. Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entries were made.

6.5 Bitches in season are not permitted to compete. The judge of a rally obedience trial must remove from competition any bitch in season, or any bitch which appears so attractive to males as to be a disturbing element. When a bitch comes into season after entry of the bitch has been submitted to the trial secretary, a veterinarian's certificate, certifying that the bitch was in season within the 10 day period preceding the trial, must reach the trial secretary on or before the date of the trial. A full refund of entry and listing fees will be given.

17.7 It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer, or competitor at a Rally Obedience Trial held under these regulations, is not subject to indignities of any kind. The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

Exhibitors, through submission of entry, acknowledge that they are knowledgeable of and will comply with the CKC Rally Obedience Trial Rules & Regulations Effective January 1, 2012, a copy of which may be obtained by calling the Central Order Desk of the CKC at 1-800-250-8040 (cost: \$6.00 + GST).

Eligibility to Compete

To be eligible to compete in these trials, the dog must be 6 months of age and registered or be eligible for registration with the CKC, have an ERN, PEN or a CKC Miscellaneous Certificate number. A dog may be spayed, neutered or debarked.

Rally Novice A - Dogs entered in this class may not have won a CKC Rally Novice (RN) title or any CKC Novice Obedience title. The handler of any dog in this class must be the owner, co-owner, or member of their immediate family. A person may enter more than one dog in this class. Dogs that have earned titles or are not the owners may enter in the Novice B class. All exercises are judged on leash and dogs must enter and leave the ring on leash.

Rally Novice B - Any dog may compete in this class until a qualifying score in the Rally Advanced class has been earned. The owner or any person may handle dogs in this class. All exercises are judged on leash and dogs must enter and leave the ring on leash. A person may enter more than one dog in this class.

Rally Advanced A - This class is for dogs that have won the Rally Novice (RN) title but have not won the Rally Advanced (RA) title or any CKC Novice Obedience title. The handler of any dog in this class must be the owner, co-owner or member of their immediate family. All exercises are judged off leash and dogs must enter and leave ring on leash. A person may enter more than one dog in this class.

Rally Advanced B - This class shall be for dogs that have won the Rally Novice (RN) title. Upon completing the Rally Advanced (RA) title a dog may continue to compete in this class indefinitely. The owner or any person may handle dogs in this class. All exercises are judged off leash and dogs must enter and leave the ring on leash. A person may enter more than one dog in this class.

Rally Excellent A - This class shall be for dogs that have won the Rally Advanced (RA) title, but have not won the Rally Excellent (RE) title or any CKC Novice Obedience title. A dog may not be entered or exhibited in this class after official notification from the CKC that the dog has won the title (RE). No dog may be entered in both Rally Excellent A & B at any one trial. The handler of any dog in this class must be the owner, co-owner or member of their immediate family. All exercises are judge off leash and the dog must enter and leave the ring on leash. A person may enter more than one dog in this class.

Rally Excellent B - This class shall be for dogs that have won the Rally Advanced (RA) title. A dog may compete in this class indefinitely. Any person is allowed to handle a dog in this class. All exercises are judged off leash and dogs must enter and leave the ring on leash. A person may enter more than one dog in this class.

Rally Advanced Excellent -Upon completion of the Rally Excellent title, qualifying scores may be accumulated from Rally Advanced B and Rally Excellent B to earn the Rally Advanced Excellent (RAE) title.

To receive the RAE title, a dog must qualify ten (10) times in both Rally Advanced and Rally Excellent at the same trial. The title will appear at the end of the dog's name and a numeric designation will indicate the number of times the dog has met the requirements, i.e. RAE2, RAE3, etc.
