GENERAL INFORMATION

Dog Show Rule Books and Obedience Trial Regulations are available from the Canadian Kennel Club. In Canada call toll free 1-800-250-8040, in the United States call 1-416-675-5511. The Show Superintendent will be in full charge of the show which will be governed by CKC Rules. Entries will be acknowledged after close of entries with receipt and judging schedule. This Show will be open from 7:00 AM until completion of judging. Dogs must be on the show grounds one hour before the judging of their class. Judging will not commence before 8:00 AM.

Owners or agents are responsible for the presence of their dogs in the judging ring. The starting time for each ring will be specified in the Judging Schedule.

PLEASE NOTE: You are responsible for cleaning up if your dog relieves itself.

The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of an accident, or other misfortune, to either dogs, exhibitors, patrons, or property.

EXHIBITORS PLEASE NOTE: (Chapter 4, Section 4.1.3 of CKC Dog Show Rules) "A judge officiating at a show held under these rules shall not be subjected to indignities of any kind during the progress of the show. It shall be the duty and obligation of the club holding the show to see that this rule is effectively carried out.

Entry fees will be refunded when a bitch entered in Obedience comes into season, after the entry of the bitch has been submitted, if a Veterinarian certificate (certifying that the bitch was in season within the ten day period preceding the trial) to the Show Secretary on or before the date of the trial. Entry fees shall NOT be refunded after the closing date. Nor in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Show Committee, or because it has been entered incorrectly. If because of riot, civil disturbance or other acts beyond the control of the EKKOC it is impossible to open or complete the show, no refund of entry fees will be made. Dogs and children must be kept under control as a courtesy to fellow exhibitors and spectators.

EXTRACTS FROM THE CKC DOG SHOW RULES

BREEDS, CLASSES, AWARDS AND STAKES 12.2.1

CKC CONFORMATION CLASSES: All of these classes must be divided by sex. Every dog within these precincts (exceptions are IN TRANSIT AREA) must be entered in one of the Regular Official Classes or for Exhibition Only.

BABY PUPPY shall be for dogs 3 months of age and under 6 months of age on the day of the show. These puppies are not eligible to compete for championship points but may compete in Sweepstakes if a 3-6 month class is offered. Judging will be After Best of Breed judging, After Group judging and BEFORE BIS judging.

JUNIOR PUPPY: shall be for dogs at least six months of age on the first day of the Show and under nine months of age on the day of the show.

SENIOR PUPPY: shall be for dogs 9 months of age and under12 months of age on the day of the show.

12-18 MONTHS - for dogs over 12 months of age but under 18 months of age.

CANADIAN BRED: shall be for dogs born in Canada, Champions of any country excluded

BRED BY EXHIBITOR: shall be for dogs owned and handled in the ring by the Breeder. The handler must be the owner/co-owner AND breeder/co-breeder of the dog. The owner/breeder must handle the dog in this class, but need not handle the dog for further awards.

OPEN : shall be for all dogs.

SPECIALS ONLY: is for dogs which have a recorded CKC Registration or Event Registration Number and have attained the required points for Championship status including at least one 2 point win either at the breed or group level. Should a dog which is entered in this class be found either not to be registered or has not completed the requirements for Championship status, all awards earned at the show will be cancelled. Dogs entered in this class will compete for Best of Breed, Best of Opposite Sex and Best Puppy if eligible.

EXHIBITION ONLY: Dogs in this class may not compete in any Regular class but may enter and compete in Non-regular classes and/or Parades if provided for in this Premium List.

EXHIBITION ONLY (3-6 MOS.): Is for dogs 3 mos. of age and under 6 mos. on the day of the show, providing the owner has entered a dog in one of the regular official classes. **Puppies in this category may enter and compete in Sweepstakes if a 3-6 months class is offered.**

CKC OBEDIENCE CLASSES

<u>Pre Novice</u>: for dogs who have not earned the title of "PCD" in Canada and has not earned the title of "CD" in Canada or any other country. Not eligible for High in Trial.

Novice A: for dogs who do not have a "C.D." Must be handled by owner or immediate family member.

Novice B: for dogs who do not have a "C.D." title in Canada. For trainers, multiple entries, or dogs who have earned titles in another country. Dogs in this class may be handled by any person.

Novice C: for any dog who has earned a "CD", "CDX", "UD" or any advanced obedience title. Exercises as in Novice and may be entered indefinitely. Not eligible for High in Trial.

<u>Novice Intermediate</u>: open to any dog having earned a "CD", "CDX", "UD" or any advanced obedience title. Can be entered indefinitely. Not eligible for High in Trial.

Open A for dogs who have earned the title "C.D." in Canada, but have not earned the title of "C.D.X.". Must be handled by owner or immediate family member.

Open B for dogs who have earned the title "C.D." in Canada. Dogs in this class may be handled by any person. Order of exercises determined by the judge and posted 30 min. before class starts.

Utility A: for dogs who have earned the title of "C.D.X." in Canada. May be handled by the owner of any other person.

Utility B: for any dog who has earned the title of "CDX" or "UD" or "MOTCH". Order of exercises will be determined by the judge and posted 30 min. before class starts..

UNOFFICIAL CLASSES:

Veterans Class: for any dog that has earned the title or CD or higher and is 7 years old or older on the day of the trial.

Brace Class: open to any 2 dogs of any breed that have earned the title of CD or higher.

Team Class: open to any 4 dogs of any breed that have earned the title of CD or higher.

CKC RALLY OBEDIENCE CLASSES

<u>Rally Novice A</u> Dogs entered in this class may not have won a CKC Rally Novice (RN) title or any CKC Novice Obedience title. The handler of any dog in this class must be the owner, co-owner, or member of their immediate family. A person may enter more than one dog in this class. Dogs that have earned titles or are not the owners may enter in the Novice B class. All exercises are judged on leash and dogs must enter and leave the ring on leash.

<u>Rally Novice B</u> Any dog may compete in this class until a qualifying score in the Rally Advanced class has been earned. The owner or any person may handle dogs in this class. All exercises are judged on leash and dogs must enter and leave the ring on leash. A person may enter more than one dog in this class.

Rally Advanced A This class is for dogs that have won the Rally Novice (RN) title but have not won the Rally Advanced (RA) title or any CKC Novice Obedience title. The handler of any dog in this class must be the owner, co-owner or member of their immediate family. All exercises are judged off leash and dogs must enter and leave ring on leash. A person may enter more than one dog in this class.

Rally Advanced B This class shall be for dogs that have won the Rally Novice (RN) title. Upon completing the Rally Advanced (RA) title a dog may continue to compete in this class indefinitely. The owner or any person may handle dogs in this class. All exercises are judged off leash and dogs must enter and leave the ring on leash. A person may enter more than one dog in this class.

Rally Excellent A This class shall be for dogs that have won the Rally Advanced (RA) title, but have not won the Rally Excellent (RE) title or any CKC Novice Obedience title. A dog may not be entered or exhibited in this class after official notification from the CKC that the dog has won the title (RE). No dog may be entered in both Rally Excellent A & B at any one trial. The handler of any dog in this class must be the owner, co-owner or member of their immediate family. All exercises are judge off leash and the dog must enter and leave the ring on leash. A person may enter more than one dog in this class.

Rally Excellent B This class shall be for dogs that have won the Rally Advanced (RA) title. A dog may compete in this class indefinitely. Any person is allowed to handle a dog in this class. All exercises are judged off leash and dogs must enter and leave the ring on leash. A person may enter more than one dog in this class.

For information only: Rally Advanced Excellent title -- Upon completion of the Rally Excellent title, qualifying scores may be accumulated from Rally Advanced B and Rally Excellent B to earn the Rally Advanced Excellent (RAE) title. To receive the RAE title, a dog must qualify ten (10) times in both Rally Advanced and Rally Excellent at the same trial. The title will appear at the end of the dog's name and a numeric designation will indicate the number of times the dog has met the requirements, i.e. RAE2, RAE3, etc.

To be eligible to compete in these obedience or rally obedience trials, the dog must be 6 months of age and registered or be eligible for registration with the CKC, have an ERN, PEN or a CKC Miscellaneous Certificate number. A dog may be spayed, neutered or debarked.

CKC NON-MEMBER PARTICIPATION FEE

APPLIES ONLY TO DOGS WHOLLY OWNED BY A NON CKC MEMBER AND ARE NOT APPLICABLE TO CKC MEMBERS

An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee. In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.
