ENTRY FEE: All UTD- \$75.00 All UTDX--\$85.00 Listing Fee- \$8.50

A listing Fee as established by the Canadian Kennel Club must accompany the entry of a dog which a Canadian Kennel Club individual registration number or Event Registration Number(ERN), is not shown on the entry form.

Entry fees shall not be refunded after the closing date in the event that a dog is absent, disqualified, excused by veterinarian or judge, or barred from competition by action of a trial committee, or because it has been entered incorrectly. Entry fees will only be refunded if there is a dog from the alternate list able to fill the spot. Entries will be refunded within 10 days of the tracking test to those on the alternate list who did not participate in the test.

Effective Jan 1/2011, an annual, non-member participation fee for awards and titles will be charged to a Canadian, non-member of CKC. The fee will match the ERN fee. In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member, or to pay the non-member participation fee of \$55.00 +HST. Failure to comply within 30 days of notification will cause all awards /titles to be cancelled. If you are a CKC member, this does not apply to you, but your CKC membership number must be included in your entry.

Entries received prior to July 31, will be returned. Entries must be mailed to the test secretary. No couriered entries will be accepted. Each entry must be mailed in a separate envelope, or they will be rejected.
