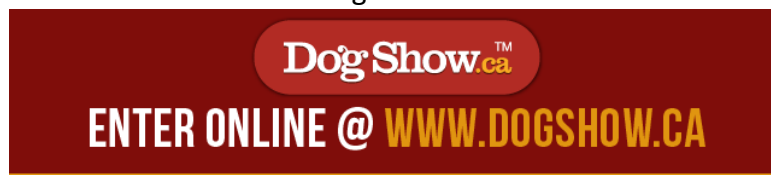

IMPORTANT CKC NON-MEMBER PARTICIPATION

The Non-Member Participation fee applies to dogs wholly owned by a resident of Canada who is not a member of the CKC. It is not applicable to CKC members or dogs owned with the CKC member. In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level. For a membership application, please go to www.ckc.ca under CKC services and forms online. The non-member participation fees paid in the calendar year (January to December) in which the dog achieved its title and/or titles.

GENERAL INFORMATION

- It shall be the duty and obligation of the club giving the show to see that a judge, official, volunteer, or any participation at an event is not subject to indignities.
- **Scent Detection Levels Offered** – Instinct, Novice (containers, interior, exterior), Open (containers, interior, exterior) and Excellent (container, interior, exterior) and Masters (containers, interior, exterior). Exhibitors can only complete in each class with 1 dog, resets will not be offered.
- **Waitlist** - if the trial fills a wait list will be maintained. Should a space become available it will be offered in the order their registration was received.
- **Day of Trial Entries** - day of trial entries will be accepted as space allows and must be submitted prior to the judges briefing. Day of entries shall be \$40 per component and only cash will be accepted. Move ups within the same trial will not be permitted.
- **Move ups** – if a qualifying score is earned in a component on Saturday, a move up can be requested for Sunday, prior to end of trial on Saturday if space and time permits. No same day move ups will be allowed.
- **Bitches in season** – effective January 2024, bitches in season are permitted to compete (see CKC Scent Detection Rule). They must run at the end of the run order for the class and must wear clean, properly fitted panties. If your female comes into season, please advise trial secretary ASAP.
- **Mixed and unrecognized breeds** - will be accepted at this trial. These dogs must have a CCN (Canine Companion Number) issued by the Canadian Kennel Club in order to participate in these trials. <https://www.ckc.ca/en/Files/Forms/Shows-Trials/Exhibitors/Canine-Companion-Number-Application>
- **Penalties issued by the club** – Dropping food while rewarding is considered contamination. Contamination of the search area will result in a non-qualifying score and any dog that urinates or defecates or vomits within the search area will be excused from the competition. Handlers will be charged for any damage done to equipment by dogs (including urinating on items excessive scratching or subsequent breaking of any item).
- **Reminder** – anyone discussing hides before the end of the trial will be excused and asked to leave as per CKC rules. Please show consideration for other competitors.
- **Withdrawal of Entries** - Please note, an exhibitor has the right to withdraw an entry up to the closing date and time as published in the premium list. This may be done by written or electronic notification and must be received by the Trial Secretary no later than the official closing date and time. If written notification is not received by that time, the dog will remain entered in the event.
- **Indoor benching will NOT be available**, please be prepared to bench from your vehicle.
