Liability Agreement

I (we) acknowledge that *Okanagan Valley Obedience Training Club (OVOTC)* has the right to refuse this entry for cause, which the organizing committee shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and win ribbons, or trophies, I (we) agree to hold this club, its members, directors, officers, agents, superintendents, sponsors of the events, or trial secretary and the owner or lessee of the premises and any employees of the aforementioned parties harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the trial premises or grounds or near any entrance thereto. I (we) personally assume all responsibility and liability for any such claim and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death, or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage, injury be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

- Dogs must be always on leash and maintaining 6 ft apart.
- Not all dogs love other dogs. Please keep your dog under control and out of other dogs' faces, even if your dog is not dog aggressive.
- Please pick up your dog's waste, and please take your dog's waste with you when you leave.

- Please clean up after yourself. There are no waste containers for your trash, please take your waste with you.
- Be kind to our judges and volunteers. Remember if you want to be treated with respect, give others the same respect.

Exhibitors are not permitted to be in possession of any of the target odors when on the trial grounds (this includes the building and the parking lot).

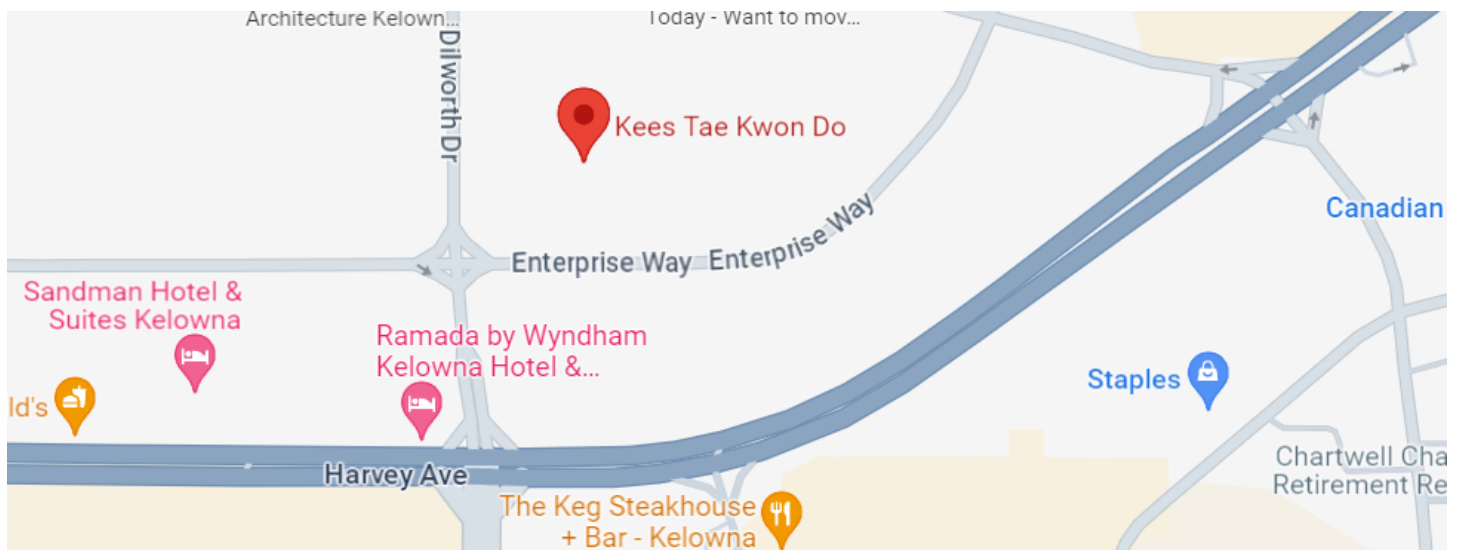
Refunds There are NO CREDITS nor refunds for anyone wishing to pull their entries after the closing date. Females in season or lame dogs will be excused. If dog is not present for assessment, a note signed by a veterinarian will be required for any refund or credit consideration.

Bitches in season are not eligible to enter this match and are not allowed on the event grounds.

Eligibility Scent participation is open to all purebred and mixed breed dogs at least 6 months of age that are individually registered with the CKC, or have an Event Registration Number (ERN) or a Performance Event Number (PEN) or eligible for the registration with the CKC or have a Miscellaneous Certificate Number (MCN) if it belongs to a CKC listed breed, or have a Canine Companion Number (CCN) if it's a mixed breed.

EVENT Verification that your entries are pending, will be emailed to you. You will be sent by the same return email, instructions to make your e-transfer. Upon completion of payment, you will be confirmed by email. PLEASE contact us prior to the event date if you have not received an emailed confirmation from us. You will be notified of a waiting list if the limited entry has been reached.
