It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Event Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

## **ENTRIES**

**Closing Date** - 6:00 PM, Sunday August 22, 2021. Entries and fees must be delivered to the Match Secretary by the closing date. This is a limited entry event however same day entries may be accepted if the limit has not been reached.

E-transfer for Sanction Match fees are strongly encouraged to the Match Secretary at [jennifer.bishop@unb.ca](mailto:jennifer.bishop@unb.ca). Exact cash or cheque entry fees will be accepted as a last resort at registration along with any disclaimer form(s). An armband and elastic will be provided for each entrant.

All entry fees must be paid to the Match Secretary at time of entry to secure a spot.

All entries must be made on an official CKC entry form. Owners are responsible for errors in making out entry forms, regardless of who completes the entry form. *Incomplete or improper entry forms will not be accepted.*

One dog per handler per level.

To comply with CKC regulations, we will be unable to accept or substitute any entry reaching the Match Secretary after the closing time and date.

**Bitches in season** shall not be eligible to enter the test (please see refunds/duplicate entries below).

**There will be no refunds on duplicate entries or overpayments:** Entry fees will be refunded when a bitch entered in Scent Detection comes into season after the close of entries if a Veterinarian's Certificate (certifying that the bitch was in season within the 10-day period preceding the trial) is delivered to the match Secretary before the starting date and the time of the trial.

**Withdrawals and Entry Fee Refunds** - If an entry withdraws between the closing date and the test date, and is replaced by an alternate, the entry fee will be refunded. Withdrawals must be made in writing to the match Secretary.

Entry fees will not be refunded if a dog is absent, disqualified, excused by a Judge, or barred from competition by action of the Test Committee.

## **RIBBONS**

A ribbon (paper) will be awarded for each qualifying score per component at all levels.

Only those dogs earning qualifying scores will receive ribbons.

## **GENERAL INFORMATION**

1. River Valley Obedience & Field Trial Club (RVO) will use all reasonable care to ensure the safety of dogs and persons at the test. However, neither RVO&FTC nor any individual will accept the responsibility for loss or injury, however caused, to any dog, person or property.
2. RVO will be adhering to any public health guidelines provided by the Government of New Brunswick, Public Health New Brunswick and/or or the facility management in effect at the time of the Sanction Match. Any significant updates to these public health guidelines will be communicated to entrants the Friday before the Sanction Match.
3. The Trial Superintendent will be in full charge of the event that will be governed by CKC rules.
4. The only dog permitted in the trial area is the dog being tested; no dogs allowed with spectators.
5. No indoor kenneling is available. All dogs must always be under control and on a leash.
6. No prong collars.
7. All exhibitors will be responsible for clean up on the grounds and surrounding areas for their own dogs and/or dogs they are handling.
8. Judging schedules and Armband Nos. will be sent as soon as possible after the Closing Date.
9. If because of riot, civil disturbance, or other acts beyond the control of the management or if it is impossible to open or to complete the match, no refund of entry fees will be made.
