### **DIRECTIONS TO THE FIELD:**


This is a large flat field.

From Vancouver: take Highway 1 East to Exit #135 (Highway 9 North to Agassiz). Follow signs to Agassiz. Pass through Agassiz following signs to Harrison Hot Springs, Mission, Vancouver. Turn right at the second traffic light. Go over the railway crossing bearing left (West). At the Junction of Highway 9 and 7 turn left onto the Lougheed Highway to Mission (Vancouver). After 1 mile turn right (north) on Cameron Road at the disused Gas Station. Humphrey Rd. is first on left. The field is at the north-west corner of the intersection.


From the US: take Exit #256 in Bellingham and turn right at the light onto Meridian and follow the signs to the Sumas border crossing (north of Lynden). For any Afghan Hound, Basenji, Borzoi, Greyhound, Ibizan Hound, Italian Greyhound, Irish Wolfhound, Pharaoh Hound, Saluki, Scottish Deerhound or Whippet that is one year of age or older on the date of the trial. All entrants must be registered with, or eligible for registration with, the Canadian Kennel Club. Hounds with breed disqualifications, altered or neutered are eligible. Hounds presently disqualified under CKC, AKC or ASFA coursing rules are ineligible for the Open Stake, but are allowed to run in the Singles Stake.
