Reminder & Point of Clarification

COVID-19 Safety Protocols

Our event is required to follow provincial regulations requiring participants present proof of 2 COVID vaccinations completed at least 14 days prior to your arrival at the trial. **Please make sure you have the necessary documentation with you when you arrive.**

- a) Proof of both COVID vaccinations administered at least 14 days prior to your arrival. OR if medically exempt, your doctor's note from your doctor on their stationary.
- b) Photo ID (i.e. driver's licence or health cards)
- c) As well as a signed copy of your COVID waiver for our files.

Without this documentation, we cannot allow you to compete or enter the building for any reason.

You can provide proof of immunization by downloading or printing your vaccine receipt from the provincial booking portal (<https://covid19.ontariohealth.ca>) or calling the Provincial Vaccine Booking Line at 1-833-943-3900.

In addition to the proof of COVID vaccination and completed COVID waiver:

- You must not attend if you have any symptoms of COVID-19, are supposed to be self-isolating/quarantining, have been out of the country in the past 14 days or have come into contact with someone that tested positive for COVID-19 or was symptomatic for COVID-19 in the past 14 days.
- There will be no food available on site.
- There will be no indoor crating, you must crate out of your vehicle.
- There will be no spectating.
- You must wear a snug fitting mask that covers your nose, mouth and chin at any time that you are in the MDKC building, or any time you cannot maintain 6 feet of distance from people not in your household.
- You must maintain 6 feet of distance from people not in your household at all times, unless it is unavoidable for a brief moment.
- There will be hand sanitizer available, please make use of it frequently.

Day of Entries, Move Ups or Change of Class

We will NOT be accepting Day of Entries.

We will NOT be accepting Move Ups between trials on the same day (i.e. Rally Trial 1 & 2)

We **WILL** accept Move Ups **between** days - that means that if your dog titles after one trial on Saturday, you can move up for the trials on Sunday if you do so **prior to the end of the trials on Saturday.**
