In payment of entry fees, the tendering of NSF cheques shall be considered non-payment of entry fees and is punishable by disciplinary action and cancellation of awards. A collection fee of \$30.00 will be added to the amount of any returned cheque.

Non-Member Participation Fee :

An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee. In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply with in 30 days of notification will cause all awards and titles to be cancelled.

Section 15.7 of the CKC Herding Rules states: It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward volunteer or competitor at a Herding Trial held under these regulations, is not subject to indignities of any kind. The Herding Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.

Please Note: There have been many changes to the CKC Herding Rules that took effect January 1, 2018. Please ensure that you review a current Rule Book so that you are aware of requirements for all levels. Rule books are available through the CKC office or on the CKC website.
