### Summary of TRIAL/TEST HERDING PROGRAMS related to these trials

The AHBA herding program offers four types of trial classes, each with three levels, & a test program with two levels. Dogs may enter the program at any level -- no title is a prerequisite for another title – but once a leg for a title has been earned at a particular level, the dog may not be entered at a lower level on that type of course or that type of stock.

#### TRIAL PROGRAM

**Herding Trial Dog (HTD), Herding Ranch Dog (HRD), ... & Herding Trial Arena Dog (HTAD)** titles, all with levels I, II & III, require two qualifying scores under **two different judges**. Titles are earned separately both as to type of course & type of stock. Progression of difficulty (level 1, 2, 3) in the trial classes echoes the progression in the training of a versatile herding dog. Trials are open to all breeds.

**Herding Ranch Dog (HRD)** ... course varies in detail while including specified requirements. Levels are differentiated by such aspects as position of handler, variations in a task or inclusion of an additional task, etc. HRD trials may use combinations of open fields, arenas & pens. **Exercises include** a gather, fetch/drive work, pen work, sorting work (required for the advanced level, optional for other levels), & various elements such as chutes, bridges, holding the sheep in place, etc.

**Herding Trial Dog (HTD)** take place on a standard course. **All levels include** an outrun, lift, fetch, wear &/or drive, & pen (the pen may be on the fence for the started level, but is free-standing for the higher levels). HTD trials are designed to be held in large fields. **HTDI:** outrun is short & handler may accompany the dog & sheep throughout the course. **HTDII:** outrun is longer & handler may accompany the dog only part way through the course.

**HTDIII:** outrun is longer, handler remains at the handler's post until time to pen, & after the pen there is an additional exercise (removing a ribbon from a marked sheep)

**Herding Trial Arena Dog (HTAD):** held in arenas on one of five courses. Levels are differentiated by restrictions on the handler's position, & the inclusion of a sorting exercise for the advanced class. Courses 1 through 4 [**this trial uses course 3**] have a basic set design but allow options such as whether to begin with a gather or take pen, type of sort used in the advanced class, and some variations in the obstacles.

#### TEST PROGRAM

**Junior Herding Dog Test (JHD)**, is run on a pass/non-pass basis & require two passing runs under different judges. Open to all herding breeds. Title is stock specific and both legs being earned on the same type of stock. Dog is handled by the owner or designated handler, although the tester may give advice. A simple course is used: two corner panel obstacles & a free-standing panel obstacle in the center of the arena, ending with the sheep being put into a fence-line pen. Handler may accompany the sheep and dog throughout the course.

### IMPORTANT AHBA RULE CHANGE - EFFECTIVE JUNE 1, 2010

ALL DOGS PARTICIPATING IN AHBA EVENTS MUST HAVE FULL INFORMATION, INCLUDING A REGISTRATION NUMBER, PROVIDED FOR ENTRY ON RECORDING FORMS.

The registration number to be used should be the dog's regular registration number (AKC, CKC, ASCA, NADAC, AAC, ETC). In the case of dogs which have more than one registration number, the owner must choose and use it consistently for AHBA purposes.

**Owners of unregistered dogs may apply to the AHBA for a tracking number to be used in place of a registration number. This tracking number is only for dogs which are not otherwise registered. The form for requesting the tracking number is on the Forms page, or may be obtained from Nancy Runyon by email at: [rerunyon@aol.com](mailto:rerunyon@aol.com), or regular mail: 1285 Hopewell Road, Harrodsburg, KY 40330-9181.**

The completed tracking number form is sent to the email or mailing address on the form, and the owner will be sent a tracking number to use for entering AHBA events. **In addition to using a consistent registration or tracking number, owners must use one consistent name when entering a dog.** An incomplete recording form received by the AHBA will not be processed.

#### **Courtesy Rules**

**Poop & Scoop courtesy rules apply.** Lots of dogs and people frequent *Sheep Creek Farm* we need to leave it as we find it. If you are in the yard, on the way to the trial area, around the arenas or in the arenas, please pick up after your dogs. If you are in a field or wildlife area, use your judgment – but if in doubt ... pick it up. There will be garbage pails around and pick-up bags for those who have forgotten them.

**Leashes.** Dogs **must be on leash** when in the trialing or yard areas and in proximity of stock or guardian dogs. This is a working farm and the jobs of the "hands" must be respected.

## Directions to Sheep Creek Farms

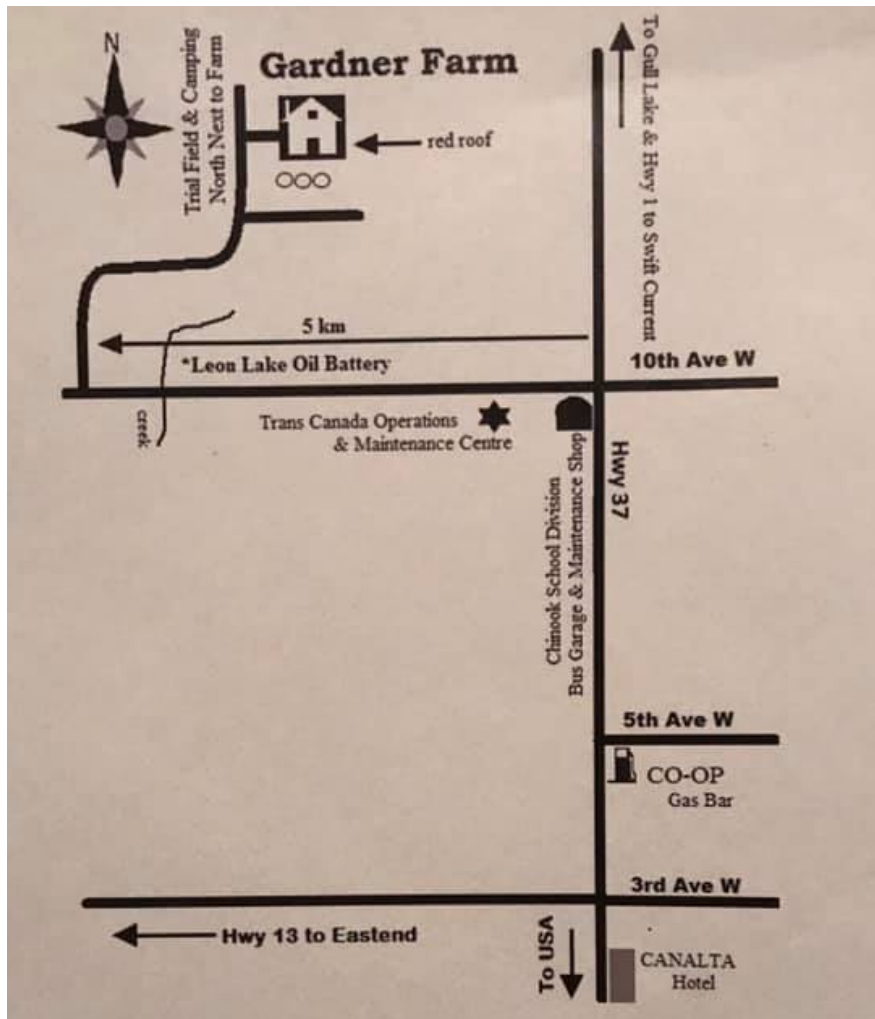
Sheep Creek Farms is just outside (west) of Shaunavon, Saskatchewan

2. From the south – Head North on Highway 37 from the Climax to Shaunavon for 53 km and turn left on 10 Ave W.
