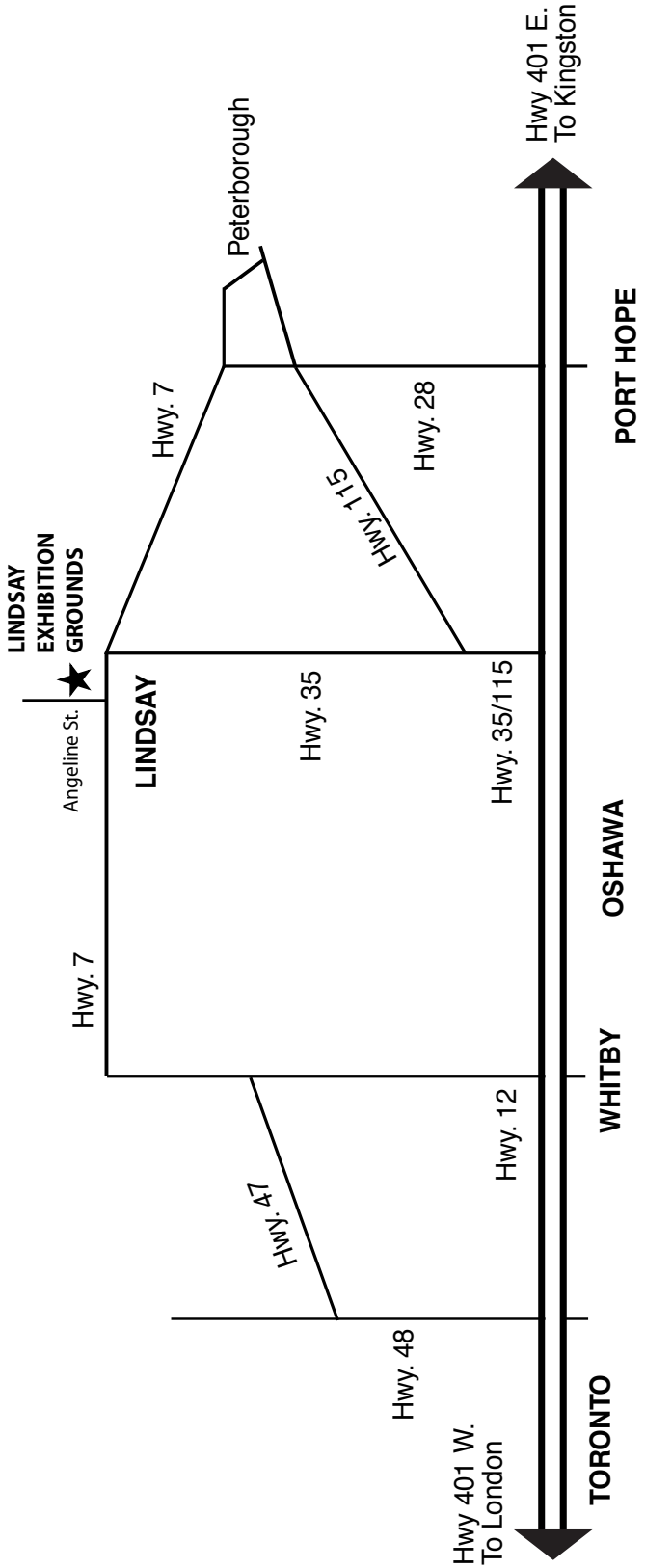

From Highway 401

Go east or west on Highway 401 to Highway 35/115 exit. Take Highway 35/115 north to the Highway 35 exit, to Lindsay. Turn left (west) onto Highway 7, just south of Lindsay. Turn right onto Angeline Street/County Rd. 4 (first traffic light). Turn right into the Fairgrounds

From Peterborough
