Day of Trial Entries welcome for Rally

Day of trial competitive entries, on a paper entry form, may be accepted on the day of the trial, no later than 1 hour before the start of the trial. Acceptance of the entry is at the discretion of the show secretary and Trial chairperson and subject to the influences of scheduling and amount of judges time available. There is a \$6./class additional fee. We will create a Standby list if you indicate by email whether you would like to enter. We will advise if there is time available.

Building opens at 7:00 am on Saturday and Sunday.
Move-in from 2:00 to 5:00 on Friday.

Day of Trial Entries begin at 7:00 am on Saturday.
Building closes 30 minutes after High in Trial or the final rally class.

Utility 10 mins/dog, Open 8.5 mins/dog, Novice 7.5 minutes/dog, Pre Novice 6.6 minutes/dog

Rally Timing -approximate-

4 mins/dog, 10 minute walk thru prior to Master, Excellent, Advanced/Intermediate and Novice classes.

6.9 Moving Up

6.9.1 A dog that is registered in the records of the CKC with an eligible number according to these rules and has fulfilled the requirements for a title in accordance with these rules may be moved to the next level of competition if the schedule permits. The transfer must be on the appropriate move-up form and submitted to the Trial Secretary by the owner or handler at least 15 minutes before the start of the class.
