GENERAL RULES

- 1. All dogs must be exercised in the exercise areas provided. Please clean up after your dog.
- 2. No refund of entry fees will be made if it is impossible to open or complete the trials because of riot, civil disturbance, or other acts beyond the control of the COKC. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Judge or event committee.
- 3. COKC will use due care and diligence for the welfare of dogs and exhibitors but will not be responsible for or assume any liability in the event of accident or other mishap caused to either dogs, exhibitors or spectators whether the results of accident or otherwise. A dog should not be touched without the permission of the owner or handler.
- 4. By City Ordinance the COKC building is a **NON-SMOKING** BUILDING. This rule will be strictly enforced.
- 5. All entries must be accompanied by the required entry fees to be considered valid. A returned/NSF cheque does not constitute a valid entry. There will be a \$25.00 fee for all returned/NSF cheques. Please make all cheques payable to: Crocus Obedience and Kennel Club (COKC). Please forward all entries and payment to the trial secretary.
- 6. Exhibitors are responsible for complete, accurate and legible information on entry forms; illegible or incomplete entries cannot be entered in the trial. No refunds will be granted after the closing date unless a replacement entry is available. Requests for refunds must be accompanied by a letter from your veterinarian.
- 7. Dogs MUST run "naked," without a collar/harness. Dogs should be brought to the ring with collars/harnesses which can easily and quickly removed and replaced. All dogs must be on leash at all times except when in the ring.
- 8. Loud/Disruptive dogs: Dogs that are loud and disruptive may be asked to locate away from the ring/crating area and/or staged away from the other dogs getting ready to compete. Any dog behaving in a threatening or aggressive manner toward another dog or a person, may be dismissed from the trial if justification is found to do so by the judge and/or trial committee.
- 9. **Bitches in season** are eligible for entry but will be required to be kept separate from all other dogs and will be run in panties at the end of their class. If bringing a bitch in season, please inform the trial secretary prior to the trial and you must inform all exhibitors at the judge's briefing.

ON-SITE CANTEEN

Breakfast, Lunch, snacks, coffee and drinks will be available for purchase in the COKC building.

It shall be deemed unsportsmanlike conduct if a person, during the running of or in connection with an event abuses or harasses a judge, trial official, or any other person present in any capacity at the event. It shall be the duty and obligation of the club holding the event to see that this is effectively carried out.
