## NON-MEMBER PARTICIPATION FEE

**APPLIES ONLY TO DOGS WHOLLY OWNED BY A NON CKC MEMBER  
AND ARE NOT APPLICABLE TO CKC MEMBERS**

An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.

In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.

## ERN

Effective Jan. 1, 1992, all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will not longer require a CKC registration number but will require an Event Registration Number (ERN). This ERN number **does not** register a dog with the CKC for breeding purposes as defined in the Animal Pedigree Act, but rather enables a foreign born and foreign owned dog to be awarded titles by the Canadian Kennel Club. Each dog must have its own number.

**To obtain an ERN number, simply do the following:**

Send a photocopy of the dog's registration certificate reflecting current ownership, for example: AKC Registration Certificate, with a written request for an ERN number.

Include with the above a cheque or money order in the amount of \$53.50 payable to the Canadian Kennel Club.

Ensure that you provide the CKC with your full return address to enable the ERN number to be sent to you. FAXED requests will be accepted. Please include your VISA/MasterCard number, expiry date, cardholders name and signature.

The ERN number **must** be applied for within 30 days of the first day of entering a CKC event. Dogs may be entered as "listed", however, failure to apply for an ERN number within 30 days of the first event will result in the cancellations of any wins, awards, and scores.

## ATTENTION US EXHIBITORS

We ask that you purchase bank drafts or money orders payable in CANADIAN FUNDS. Personal cheques will be accepted, however they must be payable in U.S. funds for the full amount of the entry. **DISCOUNTED CHEQUES OR MONEY ORDERS WILL NOT BE HONOURED.** Please do not send personal cheques marked “Payable in Canadian Funds” or “At par” Your cooperation is appreciated.

## GENERAL INFORMATION/SHOW REGULATIONS

1. The show building will be open Thursday evening from 6 pm to 10 pm, and at 7 am until 11 pm each day of the show.
2. All entries must be complete, including the full name & address of the owner of the dog. The Show Committee reserves the right to refuse any entry subject to CKC rules. Exhibitors must abide by errors made in entering their dogs, **regardless of how and by whom entries were made.** Changes or cancellations after closing date are prohibited except according to CKC rules.
3. An exhibitor entering puppies 3 to 6 months of age may not enter more than two of that age.
4. **No refund of entry fee will be made** if, because of riot, civil disturbance, or other acts beyond the control of the Wheat City Kennel Club, it is impossible to open or complete the show.
5. The Wheat City Kennel Club will use due care & diligence to ensure the welfare and safety of dogs and exhibitors but will not be responsible for, nor assume any liability in the event of an accident or other misfortune to dogs, exhibitors, or spectators. **PLEASE NOTE:** Dogs left in the building at owners' risk. There will be **no watchman** hired by WCKC on duty at night in the show and kennel area.
6. Dogs must be in the show building at least one hour prior to the judging of their breed. It is the responsibility of exhibitors to have their dog(s) at ringside when required for judging. Dogs not required for further judging may be excused. **ONLY DOGS ENTERED IN THE SHOW/TRIAL ARE ALLOWED IN THE BUILDING.**
7. The Show Superintendent will be in full charge of the shows and trials.
8. Wheat City Kennel Club is **not** be responsible for contracts made with the show photographer
9. Exhibitors **must exercise their dogs in the designated areas provided** Exhibitors are responsible for cleaning up after their dogs. **No private exercise pens will be allowed without permission from the show superintendent**
10. All dogs classed as "In Transit" must be identified to the Show Secretary before the start of the first show.

THE KEYSTONE CENTRE IS A NON-SMOKING FACILITY. PLEASE ABIDE BY THIS PROVINCIAL LAW. There are smoking areas outside the building.



# CHAMPIONS AND CHAMPIONSHIP POINTS

**SECTION 1** – A dog awarded **Winners** at a championship show held under the Dog Show Rules shall be credited with a number of championship points (ranging from 0 to 5) and the determination of the number of championship points to be accredited to a dog awarded **Winners** shall be provided hereunder.

**SECTION 2** – The schedule to be employed in the determination of the number of points to be allocated to a dog awarded **Winners** shall be as follows.

<b>DOGS COMPETING</b>	1	2	3-5	6-9	10-12	13 or more
<b>Points Allocated</b>	0	1	2	3	4	5

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for championship points.

The new system provides for additional points if a dog awarded **Winners** also places in the **GROUP** as listed below.

A class dog awarded **Best in Show** at an all-breed championship show will be credited with five (5) points inclusive of any points earned at the breed or group level. In **no** case may a dog earn more than **five (5)** points at a **single show**.

In order for a dog to be recognized as a Champion and its owner provided with a Championship Certificate, the dog must: (a) earn at least 10 championship points under at least 3 different judges; and, (b) be individually registered in the records of the CKC or have an Event Registration Number. (c) have earned at least one 2 point win either at the breed or group level. (15.1.13).

**Best Puppy in Breed** – Where a dog awarded Best of Breed is not a puppy, those puppies which have not been defeated either directly or indirectly by another puppy in the breed will compete for this award.

Judging follows the award for Best of Breed. A puppy awarded Best Puppy in Breed, is **NOT** required to stay to compete for Best Puppy in Group (15.3.1f)

## **MOVING CLASS DOGS TO SPECIALS**

A dog which is individually registered in the records of the CKC or has an ERN number at the time of closing of entries, and has completed the requirements for a championship in accordance with the provisions of **Chapter 20** of the **Dog Show Rules**, after the closing date and time for entries for a show, but whose championship is yet unconfirmed by the CKC may be transferred from one of the regular classes to "Specials Only" providing the transfer is submitted to the show secretary in writing **at least one (1) hour prior to the opening of the show**, by the owner or handler.

**Effective January, 1994:** If your dog has the required number of Championship points and you do not have your registration number before entries close, and you receive your registration **BEFORE** the date of the show, you may move your dog up to Specials if you provide the Show Secretary with the registration number and the dog has been entered in the classes as a **LISTED** dog. Listing fees, however, **WILL NOT** be refunded.

An error in the class, date of birth or sex may be amended on the entry form up to one hour before the start of the show. Rule (8.2.5)
