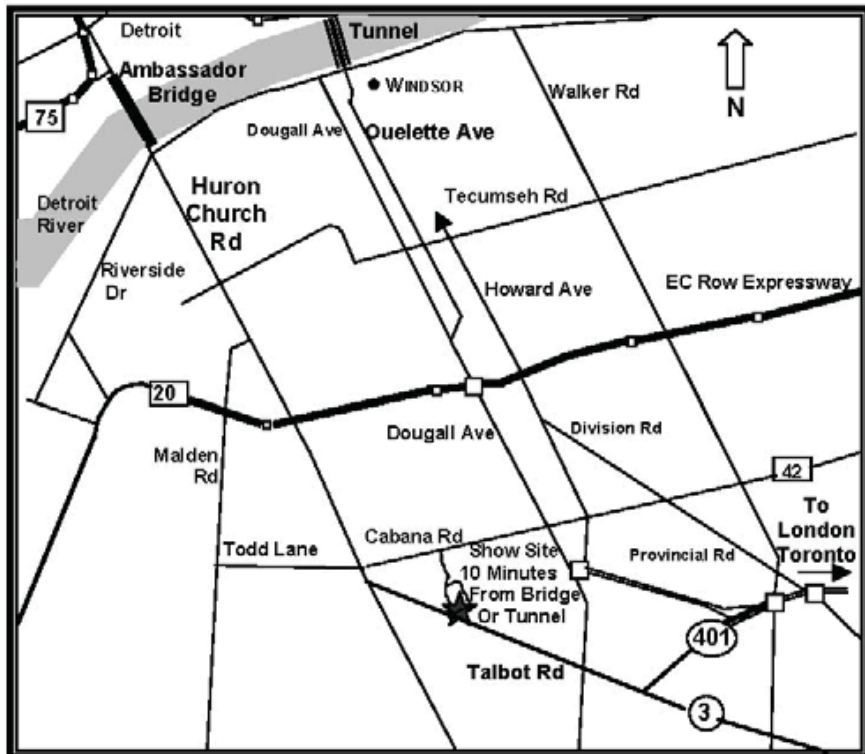

**NON-MEMBER
PARTICIPATION
FEE**

Effective January 1, 2011:

- a) A non-member participation fee will be charged to a resident of Canada who is a non-member of the CKC. The fee will be \$59.40 plus applicable taxes.
- b) The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.
- c) In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.
- d) The fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

REGULATIONS**

The Exhibitor is responsible for knowing and complying with the Obedience Rules and Regulations of the Canadian Kennel Club.

Chapter 19 - Section 19.7 of the Obedience Rules and Regulations states: It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer, or competitor at an Obedience Trial held under these regulations, is not subject to indignities of any kind. The Obedience Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

Chapter 17 - Section 17.7 of the Rally Obedience Rules and Regulations states: It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer or competitor at a rally Obedience Trial held under these regulations, is not subject to indignities of any kind. The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

A VERY IMPORTANT NOTICE

Any Exhibitor who allows their dog to defecate or urinate inside or outside the building other than in the designated Exercise Areas, without immediately cleaning up or arranging for a clean-up may not be permitted to exhibit at future shows held by this club.

**EVENT
REGISTRATION
NUMBER (ERN)**

Effective Jan. 1/92, all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will no longer require a CKC registration number but will require an Event Registration Number (ERN).

The ERN number MUST be applied for within 30 days of the first day of entering a CKC event.

**BITCHES IN
SEASON**

If a bitch entered in the Obedience Trials comes into season after the closing date, please notify the Trial Secretary. We will refund all entry fees and listing fees if we are in receipt of a Veterinarian's Certificate stating that the bitch was in season within the 10 day period preceding the trial. This certificate must be delivered to or reach the Trial Secretary on or before the date of the trial.

**ENTRY
INFORMATION**

1. No entry will be accepted unless all particulars called for on the entry form are completed in full. Handlers or agents please note the full name and address of all owners must be filled in.
2. Incomplete entries will be returned. No entry will be accepted unless accompanied by entry fees. Telephone and telegraph entries cannot be accepted. Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entries were made.
3. There is no refund for duplicate cheques. Every effort will be made to find all duplicate entries, however if the entry has been processed and appears in the official catalogue, no refund will be made.
4. Alterations, substitutions or cancellations of any entry after the closing date is prohibited, except moving Class Dogs to Specials. Only dogs which are already registered in the Canadian Kennel Club Stud Book, or are eligible for such registration can be entered. The committee reserves the right to refuse any entry subject to CKC Rules. **Entries positively close, MONDAY, APRIL 20, 2015 AT 8:00 P.M. OR WHEN THE LIMIT OF 420 MINUTES FOR EACH JUDGE, EACH DAY IS REACHED.** and must be in the hands of the Show Secretary by that date.
5. Identification cards and judging schedules will be mailed as soon as possible after the entries close. Identification cards must be presented upon arrival at the show.
6. Tendering of NSF cheques in payment of fees shall be considered non-payment of fees and is punishable by disciplinary action. **Any N.S.F. cheques will be subject to a \$20.00 service charge.**

MOVING UP

6.8.1 A dog that is registered in the records of the CKC or has a PEN, and ERN, or a MCN and has fulfilled the requirements for a title in accordance with these rules but at the time of the closing of entries for the trial has not received confirmation of the title may be moved to the next level of competition providing the request is submitted to the trial secretary on the appropriate move-up form by the owner or handler a minimum of one hour before the opening of the first trial on that day, schedule permitting.

6.8.2 When one or more trials are held on the same day in the same venue, the request for moving the dog up must be made a minimum of one hour prior to the scheduled start of the trial for which the dog is being moved up to, schedule permitting. The Trial Secretary shall amend the judge's book and the marked catalogue, which is to be sent to the CKC with the requests attached to the appropriate entry forms.

GENERAL INFORMATION

- The Show Superintendent will be in full charge of the show which will be governed by CKC Rules.
- Windsor All Breed Training and Tracking Club will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume liability in the event of accident, or other misfortunes, to either dogs, exhibitors or patrons.
- If, because of riot, civil disturbance or other acts beyond the control of management, it is impossible to open or to complete the show, no refund of Entry will be made.
- Dogs should arrive in adequate time for their breed judging (allowing for absentees) and will be excused each show when not required for further judging. It is the responsibility of the exhibitors to have the dog at ringside when the dog's class is scheduled for judging. Waiting for dogs will not be possible and handlers with several breeds must arrange for alternate handlers if judging times for their breeds conflict.
- Judging will commence at 8 a.m. Saturday, May 2, and Sunday May 3, 2015. A later starting time may be specified in the judging schedule. Starting time of each ring will be specified in the judging schedule.
