Bitches in season: Any bitch in season will run last, please advise the test secretary prior to the draw if your bitch is in season.

Awards and no-host lunch: Awards will take place after the last track is run, you are welcome to bring your lunch, this will take place outdoors.

Discipline Regulation: "It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules, is not subject to indignities of any kind. The Tracking Test Committee Chair shall promptly report to the CKC any infringement of this regulation and the Discipline committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred."

Non-member participation fee: A participation fee will be charged to a resident of Canada who is not a member of the CKC. The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual. In order for the title to be awarded the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level. This applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members
