- 🦴 A CKC Listing Fee of \$9.49 Cdn or US, per entry, must be paid for dogs eligible for a CKC registration or Event Registration Number (ERN), but who do not yet have their number. The registration number must be applied for within 30 days of the first day of entering a CKC event.
- 🦴 A dog eligible for a PEN number must have their PEN number prior to entering the test, and may not enter as a Listed dog.
- 🦴 U.S. Exhibitors: US cheques accepted, but please do *not* mark US cheques "Payable in Canadian Funds" or "At Par". Bank drafts or Money orders payable in Canadian funds are also acceptable.
- 🦴 An NSF cheque will be subject to a \$20.00 service charge. The Entry fee plus NSF service charge must be paid in cash prior to competing.
- 🦴 Faxed, emailed, or hand delivered entries will not be accepted.

## All-Breed Field & Urban Tracking Tests – General Information

### ELIGIBILITY:

Certification is not required to enter a Canadian TD test

A CKC TD title is a prerequisite for entering either a CKC UTD test or TDX test.

Canadian entrants who are not CKC Members: As of January 1, 2011, the CKC has instituted an annual Non-Member Participation Fee. This fee applies only to dogs wholly owned by a non-CKC member, and is not applicable to CKC members or dogs co-owned by CKC members. Non-CKC member participants must either purchase a CKC membership or pay the Non-Member Participation Fee (currently \$57.60 + HST) within 30 days of notification, or awards and titles will be cancelled by the CKC.

### CONFIRMATION, ALTERNATE LIST, and REFUNDS:

Entries will close once the trial limit has been reached, even if the closing date has not arrived. Additional entries will be assigned a position on an 'Alternate List' in the order received. The Test Secretary will notify all entrants of their acceptance into the trial or their position on the Alternate List.

If an entered dog is withdrawn after the closing date, a refund will be given if the vacancy is accepted by an Alternate. Alternates will be contacted in Catalogue order and may accept or decline. Remaining Alternates as of test day are encouraged to attend the draw in case there is a withdrawal or no-show of a confirmed entrant.

### BITCHES IN SEASON:

Bitches in season will be permitted to compete, but will be assigned the last track. Please advise the Test Secretary immediately upon arrival at the meeting place, or earlier if possible.

### MEETING PLACE AND DRAW FOR TRACK ORDER:

The Draw will be held each day at Tim Horton's at the corner of Oliver Road and Golf Links Rd. Please request a map if needed.

Saturday, May 26th: 8:00 am Draw for TD & UTDX Tests - Judge: Marie-P Babin

Sunday, May 27th: 8:00 am Draw for UTD & TDX Tests - Judge: 'Marge' Schultz

Any primary entrant(s) who is absent at the assigned draw time will forfeit his/her position to the first Alternate present. Please be sure to arrive on time for your draw.

AWARDS & LUNCHEON: Each passing team will be awarded a Rosette and Medallion from TBK&TC, after completion of the days tests. Bring your camera for a photo with the judge !

### DISCIPLINE: RULE 14.7

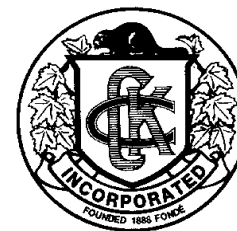
