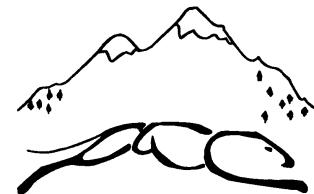

The **Rachelle Descent Founder's Trophy** will be awarded to the hound achieving top overall aggregate for the year. Your hound must compete at all FGC trials throughout the year to be eligible for this award. **For 2012, this will be nine events.** The trophy will be awarded the final day of our September trial weekend.

Lure Coursing Booster Awards

The *Afghan Hound Club of Canada*, *Borzoi Canada*, the *Ibizan Hound Club of Canada*, and the *Stampede City Whippet Club* are pleased to boost the entries in their breeds. Prizes will be awarded for Best of Breed through to NBQ.

PLACEMENTS AND AWARDS

CKC Lure Coursing Rules - Chapter 7, Section 1:

Championship points are awarded to regular stakes only on the following basis:

- 1st Place: 4 x number of hounds competing in stake with a max. of 40 points
- 2nd Place: 3 x number of hounds competing in stake with a max. of 30 points
- 3rd Place: 2 x number of hounds competing in stake with a max. of 20 points
- 4th Place: 1 x number of hounds competing in stake with a max. of 10 points
- NBQ: Next Best Qualifying Score - no points

No hound shall receive a placement or points if it does not score at least 50% of the total possible combined scores. If a hound has been **excused** in the preliminary run, that hound shall not count as having been in competition.

ADDITIONAL CONDITIONS

- Stakes will be split if the entry is 24 or more hounds at the time of Roll Call.
- Hounds will be run twice, in braces or trios (except single dog entries) unless dismissed, excused or declared ineligible.
- Bitches in season and lame hounds will be excused and their entry fee refunded, provided notice is given prior to or during roll call.
- Hounds not present at roll call shall be scratched with no refund of entry. No Exceptions.
- All handlers must use a slip lead when releasing their hounds. A **STANDING START** will be used on Tally-Ho.
- Muzzles and catch collars may be used at the handlers' discretion. Leg wrappings must be a neutral color to comply with CKC rules.
- There will be a \$5 fine for dogs found loose on coursing field after roll call and before completing Best in Field. There will be a \$20 fine for anyone caught not cleaning up after their hound.
- Bring your own water, and shade.

ENTRIES CANNOT BE ACCEPTED BY PHONE EXCEPT IN THE EVENT OF A POSTAL STRIKE IN WHICH CASE CALL Rachelle (403) 272-1519.

ELIGIBILITY TO ENTER THESE TRIALS

Open to any Afghan Hound, Basenji, Borzoi, Greyhound, Ibizan Hound, Irish Wolfhound, Italian Greyhound, Pharaoh Hound, Saluki, Scottish Deerhound & Whippet. All entrants must be registered or eligible for registration with the CKC. Spayed and neutered dogs may compete.



DOGS PRESENTLY DISQUALIFIED UNDER ASFA, CSFA, AKC OR CKC RULES ARE NOT ELIGIBLE. HOUNDS MUST PRE-QUALIFY BEFORE ENTERING THEIR FIRST TRIAL IN CANADA. IF APPLICABLE, PLEASE PROVIDE PROPER CERTIFICATION WITH YOUR ENTRY.

It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

NOTE: Should field or weather conditions warrant, the Club reserves the right to alter this plan. A Drag lure machine with white plastic lure will be used on all courses. The coursing area is totally fenced with white plank fencing and rows of trees.
