No Entry can be accepted unless and until all particulars called for on the entry form are completed thereon, and accompanied by the Signed Waiver and full Entry Fee.

No FAX, telephone or electronic entries will be accepted.

Incomplete entries cannot be accepted and may be returned to the Exhibitor.

TCN – Temporary Competition Numbers

If a dog is not registered individually in the records of the CKC, it may be entered at a trial held under these rules with a Temporary Competition Number (TCN), providing that the number is obtained before the closing date of entries. Once the dog is permanently registered or has an ERN, the TCN will no longer be valid. TCN's can be obtained online through the CKC Member Portal. Exhibitors may also obtain a TCN by completing a printed application and submitting it to the CKC by mail, or by contacting the Shows and Trials Division at 1-855-364-7252.

Day-of-Trial Entries: If time permits, Day of Trial entry will be available for the Second Trial *only*. Entries with full payment in accordance with the fee schedule must be submitted to the Trial Secretary by the owner or handler *at least* 30 minutes before the start of the Component to be entered.

Move-ups: A dog that fulfills the requirements for a title in accordance with the rules during the first Trial of the day may move to the next level of competition for the second Trial. The transfer must be on the appropriate move-up form and submitted to the Trial Secretary by the owner or handler *at least* 30 minutes before the start of the Component.

NSF Cheques: 6.3.3 Tendering of a dishonoured cheque or cancellation of an Interac® eTransfer in payment of entry fees shall be considered non-payment of entry fees, and is an offence punishable by disciplinary action and cancellation of awards. In addition, a \$40.00 service charge may be levied by the Club.

LIMITED ENTRY means advance entry may be limited once the Scent Detection Judge's assignment reaches 60 components in one day, and will close at the advertised closing time. The number of entries in any or all components may be limited in each trial. The number of entries for dogs with the same Handler in a single component and/or class may be limited in each trial. 'When the advertised limit has been reached, all remaining entries may be assigned a position (by class) on the wait list. Additional 'wait list' entries above the limit may be taken at the discretion of the event committee, and invited to participate prior to the advertised closing date. Owners of wait list dogs will be informed of their position on the wait list and may choose not to participate. Fees will not be refunded for any reason other than a bitch being in season and to those on the wait list who did not participate in the trial.'

TROPHY LIST

Through the generous support of its members and friends the Poodle Club of Canada will offer the following:

Flat Ribbons will be awarded to any dog achieving a qualifying score in all classes/components. New Title rosettes will be awarded to any dog completing a title in these trials.

CKC REGULATION 4.1.5:

It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

Note Electronic Communication

All entry confirmations, Judge Schedule and any other notices will be sent from the Secretary@thepoodlefarm.com to the Handler or Owner as indicated on the Official Entry Form. It is the Entrants responsibility to ensure that their email account settings are configured to designate Secretary@thepoodlefarm.com as a Safe Sender, Trusted Sender, Always Allow or such other designation as may be required to prevent your email service from flagging such communications as Spam/Junk and blocking from your Inbox.

NOTES TO COMPETITORS

Handlers may be charged for any damage due to intentional biting, hard scratching, pouncing or other by the dog that causes damage to the container/object/area.

Reminder that competitors and/or spectators discussing hides before all teams have run for a particular class will be excused and/or asked to leave as per CKC rules. Please show consideration for other competitors.

Handlers and their dogs may not bring wearable (ie Go Pro cameras) video recording equipment into the Search Areas. Handlers may set-up a video recording device to record their search prior to entering the Search Areas, however under no circumstances may they share the video with any handler competing in the same class who has not yet run.

No designated warm-up area will be made available. No training may be performed within the trial precincts on the day of the events.

New for 2021: Collars, Leashes, Harnesses and Accessories (9.4.1) Dogs must wear a properly fitted collar or harness subject to approval by the Judge. The harness will be constructed of plain, pliable material and will be designed so that there is minimal restriction of the dog's movement. No special training tools, such as electronic collars, prong collars, head halters, choke chains, or no-pull harnesses may be used during the search. Martingale collars are permitted. No odor-emitting collars (such as no-bark collars that spray citronella, or DAP calming collars) may be worn or present in the search area. (9.5.3) Belly bands are not permitted.

Judges are not required to wait for dogs. The Handler of each dog is solely responsible for having it ready at the search area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of locating dogs that are not brought into the ring when required. *Note: Handlers should be prepared to run 2 components (ie Container-Interior) Back to Back.*

It is the responsibility of the exhibitor to be familiar with the rules pertaining to the event in which they are competing. Copies of the CKC Scent Detection Rules & Regulations are available from the Canadian Kennel Club. Tel: 1-800-250-8040.

Safety, behavior and liability: The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The Canadian Kennel Club and its officials, agents, employees, etc., the Poodle Club of Canada, and The Poodle Farm will assume no responsibility for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The Canadian Kennel Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the Canadian Kennel Club or any official thereof.

REFUNDS: No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. A dog pulled after closing because of injury or other medical condition is not eligible for a refund.

BITCHES IN SEASON are not permitted to compete. When a bitch comes into season after entries close a Veterinarian's certificate which certifies that the bitch was in season within ten days of the trial must reach the Trial Secretary on or before the day of the trial and the club will refund the entry fees.

GENERAL INFORMATION

- The **trial precincts** shall be the non-residential buildings and surrounding grounds of The Poodle Farm. In accordance with CKC rules only dogs entered in official classes are permitted within the Trial Precincts. *There is no "Exhibition Only" class being offered at this trial.*
- Show Superintendent has full charge of the show which is governed by CKC rules.
- The Poodle Club of Canada and The Poodle Farm will not be responsible for, or assume liability in the event of accident, or other misfortunes, to either dogs, exhibitors, patrons or their property.
- Flexi-leads may not be used on The Poodle Farm property outside the Search areas.
- No smoking, vaping or cannabis use is permitted on The Poodle Farm property.

- No special area will be designated for reactive dogs.
- Food: You may want to bring your own packed lunch. Water and pop will be available for sale at the site. The local Tim Horton's, grocery store and restaurants are about 7 minutes from the trial venue.

Notes to Competitors - Special Information

Due to ongoing concerns with the coronavirus disease, we are asking for your cooperation to limit the possible spread of the disease, and ensure an environment which is safe and comfortable for all participants.

Please do not participate if you answer "Yes" to any of the following in the 14 days prior to the trial:

- Are you experienced any fever, cough, or have difficulty breathing?
- Have you returned from the US or other International destinations?
- Have you been contact traced to a COVID-19 case?
- Have you had close contact with a person with acute respiratory illness who has been outside Canada?

Special Measures and Instructions:

- Face Masks/Face Coverings may be required in all indoor spaces. Masks or face coverings are strongly
 recommended in all outdoor spaces when 2m physical distancing cannot be reasonably assured, and
 should be worn in proximity to the building entrance or information boards. Your cooperation and
 understanding are appreciated. This requirement may be amended depending on government & local
 health guidance.
- Indoor shoes will be mandatory as usual from the time you enter the building until you leave.
- Please park so social distancing is adhered to.
- There will be no indoor crating. Please crate from your vehicle while you are here for the trial.
- To facilitate social distancing, we ask that you do not bring friends, children, spouses or others unless you need them to provide mobility assistance at the trial.

 picture with your phone.
- All briefings will be done outside the building
- No special area will be set aside for reactive dogs.
- Unfortunately we may not allow spectators in the building. You may have someone video your
 exterior search if in the opinion of the Judge it can be done while maintaining physical distancing,
 however under no circumstances may they share this with any handler competing in the same class
 who has not yet run.
- Ribbons are not self-service; we will make every effort to have ribbons and scoresheets available as quickly as possible. Please bring an envelope with your name that we can put your ribbons and scoresheets in after results are announced.
- We encourage you to leave the facility promptly when you are done for the day.
- No lunch will be served. You may bring your own refreshments if you are staying through multiple classes.

Health, Sanitization & Trial Workers:

- We will have a team member cleaning all "touch" areas during the day
- The restroom attached to the garage will be the only facility available to competitors.
- Paper towels, soap, and hand sanitizer is available throughout the facility.
