ALL SCRATCHES MUST BE REPORTED TO THE FIELD TRAIL SECRETARY 24 HOURS

BEFORE THE TRIAL. Entry fees will be refunded only for bitches in season or for injured dogs, upon receipt of a veterinarian's certificate. Once the catalogue has been printed a \$10.00 surcharge will apply.

NOTICE TO TRIALERS:

Excerpt from CKC R ules and R egulations it shall be the duty and obligation of the event giving club to see that a judge, club official, volunteer or any participant at a hunt test held under these regulations, is not subjected to indignities of any kind. The H unt T est Committee Chair shall promptly report to the Canadian K ennel Club any infringement of this regulation, and the Discipline Committee shall have the authority to take such action it deems fit on receipt of a report indicating this has occurred.

Please check in with the Marshal upon arrival at your stake. It is the responsibility of the handler to inform the Marshal if they have dogs running in other stakes, and the Marshall has the authority to move dogs for the efficiency of the test.

Handlers may be required to handle a gun or replica during the test. Gun Safety is considered as part of the test.

All handlers MUST wear dark or camouflage clothing.

Handlers are expected to be familiar with the CKC Hunt Test Rules and

Regulations.
