**CANADIAN KENNEL CLUB SCHEDULE OF CHAMPIONSHIP POINTS**

SECTION 2. The schedule to be employed in the determination of the number of points to be allocated to a dog awarded WINNERS shall be as follows: (\*Includes the dog awarded Winners.)

Dogs Competing*	1	2	3 to 5	6 to 9	10 to 12	13 or more
Points Allocated*	0	1	2	3	4	5

To determine the number of championship points earned by a dog awarded Winners, total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best of Opposite Sex and then consult the schedule set forth above.

The system provides for additional points if a dog awarded winners also places in the Group as listed hereunder. A dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for championship points. Further section 15.1.12 {C} has been added and states the dog must: "have earned at least one 2 point win either at the breed level or group level."

If the dog awarded Winners is also Best of Winners, Best of Opposite Sex or BEST OF BREED, the number of championship points will depend on the total Number of dogs defeated directly or indirectly for the award.

In addition to Championship points allocated at the breed level, a dog awarded Winners which also places in the regular GROUP competition shall be credited with the following additional points, provided that the dog has defeated another dog at the Group level, and that not more than 5 points will be credited to a dog for a single show.

A dog may not be credited with more than 5 points in a single show. A class dog which Also places BEST IN SHOW at an All Breed Championship Show shall be credited with 5 championship points inclusive of any points earned at the breed and group level in counting the number of eligible dogs in competition, dogs that have been excused, disqualified, dismissed from the ring by the judge, shall be included in calculation

(Absentees are not counted) **To earn a Canadian Championship, a dog must earn at least ten championship points under at least three different judges, and be individually registered with the Canadian Kennel Club, or have a C.K.C. EVENT REGISTRATION NUMBER (ERN) and have 1 two point win from the Breed or Group level.**

## **REGULAR CLASSES**

The following classes will be provided, divided by sex.

**JUNIOR PUPPY** - 6 months & under 9 months on the day of the show

**SENIOR PUPPY**- 9 months & under 12 months on the day of the show

**12 - 18 MONTH** 12 months & under 18 months on the day of the show

**CANADIAN BRED** – Dogs born in Canada. Champions of any country are excluded.

**BRED BY EXHIBITOR** – Dogs owned and handled in the ring by the breeder. The handler must be the owner/co-owner and breeder/co-breeder of the dog. The owner/breeder must handle the dog in this class, but need not handle the dog for further awards.

**OPEN CLASS** - shall be for all Dogs.

**VETERANS** - open to all dogs over 7 years of age and older on the day of the Specialty. The winners of the Veterans Male & Female classes will not compete for Championship points but go directly into the Best of Breed competition. Veteran dogs may be neutered or spayed.

**SPECIALS ONLY** - This class will NOT be divided by sex. A dog may be entered for “Specials Only” and such dog shall compete for Best of Breed award. If eligible it must compete for the award of Best of Opposite Sex. Should a dog entered for Specials Only place in its group at the show then all awards the dog earned at the show will be canceled if, at the time of closing of entries for the show, the dog was not registered individually in the records of the Canadian Kennel Club or if the dog has not earned all the championship points required for championship status. The entry of a Listed Dog in this class is NOT allowed.

## **NON-REGULAR CLASSES**

**EXHIBITION ONLY** - Dogs entered in this class may not compete in the regular breed classes.

### **CLASSIFICATION – OBEDIENCE**

**NOVICE A** - The Novice A Class shall be for any dog of any recognized or listed breed which has not earned the title of C.D. Only one dog per handler is allowed in this class, and that person must handle the dog in all exercises. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families, and must be eligible to handle under section No person who has trained or exhibited a dog that has earned a C.D.X. title shall be allowed to handle a dog in this class. When a dog is wrongfully entered in this class, any score awarded will be cancelled.

**NOVICE B** - The Novice B Class shall be for any dog of any recognized or listed breed which has not earned the title of C.D. Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class. The same handler must handle each dog in all 6 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the Group Exercises. No dog may be entered in both the Novice A and Novice B Class at any one trial.

**NOVICE C** - The Novice C Class shall be for any dog of any recognized or listed breed that has earned the title C.D., C.D.X., U.D. or any Obedience Trial Championship Title prior to the losing date of the trial in which it is to be entered.

**PRE-NOVICE** -The Pre-Novice Class is an elective class and earning the title is not a requirement to enter Novice Classes. The Pre-Novice Class shall be for any dog of any recognized or listed breed which has not earned the title of P.C.D. Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class. The same handler must handle each dog in all 5 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the Group Exercise. Only dogs that have not earned the title of C.D. may enter the Pre-Novice class.

**NOVICE INTERMEDIATE CLASS** - The Novice Intermediate Class is an elective class and earning the title is not a requirement to enter the Open Classes. Novice Intermediate Class shall be for any dog of any recognized or listed breed which has earned the title of Companion Dog, Companion Dog Excellent, Utility Dog or any Obedience Trial Championship. Scores earned by dogs competing in this class are not eligible for High in Trial. Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class. The same handler must handle each dog in all 6 exercises.

**OPEN A** - The Open A Class shall be for any dog of any recognized or listed breed which has earned the title of C.D. but has not earned the title of C.D.X. . The handler of any dog in this class must be the owner or a member of their immediate families. Only one dog per handler is allowed in this class, and that person must handle the dog in all exercises. Any person who has trained or exhibited a dog that has earned a U.D. title may not handle a dog in this class. A dog which has earned its C.D.X. title is not eligible for entry in this class but may be entered in the Open B Class. When a dog is wrongfully entered in this class, any score awarded will be cancelled.

**OPEN B** - The Open B Class shall be for any dog of any recognized or listed breed which has earned the title of C.D. Dogs which have earned the title of C.D.X. or U.D. must enter in the Open B Class. Dogs in this class may be handled by the owner or any other person. A person may enter or handle more than one dog in this class. The same handler must handle each dog in all 7 exercises unless he has 2 or more dogs entered. In such case, he must have an additional handler for each extra dog when they are judged together in the Group Exercises. No dog may be entered in both the Open A and Open B classes at any one trial. A dog eligible for entry in the Utility Class at any obedience trial held under these rules is also eligible for entry in the Open Class B at the same trial. Prior to the start of judging, the judge will decide the order of exercises to be performed. This order will not be disclosed to exhibitors until it is posted at ring side, approximately 30 minutes before the start of the class. In future assignments, judges are required to alternate the six orders of exercises so that each set will be used approximately the same number of times.

**UTILITY A** - The Utility A Class shall be for any dog of any recognized or listed breed which has earned the title of C.D.X. but has not earned the title of U.D. Any person who has trained or exhibited a dog that has earned a M.O.T.Ch title may not handle dogs in this class. The handler of any dog in this class must be the owner or a member of their immediate families. Owners may enter more than one dog in this class. The same person must handle the dog in all exercises. When a dog is wrongfully entered in this class, any score awarded will be cancelled.

**UTILITY B** - The Utility B Class shall be for any dog of any recognized or listed breed which has earned the title of C.D.X. or U.D. Dogs in this class may be handled by the owner or any other person. Owners may enter more than one dog in this class. The same person must handle the dog in all exercises. No dog may be entered in both the Utility A and Utility B classes at any one trial. Prior to the start of judging, the judge will decide the order of exercises to be performed. This order will not be disclosed to exhibitors until it is posted at the ring side, approximately 30 minutes before the start of the class. In future assignments, judges are required to alternate the six orders of exercises so that each will be used approximately the same number of times.



## **CLASSIFICATION - RALLY OBEDIENCE**

**RALLY NOVICE A** - Dogs competing in this class may not have won a CKC Rally Novice (R. N.) title or any CKC Novice Obedience title. No handler who has exhibited a dog through its CKC CDX (Companion Dog Excellent) title or instructed dog training classes shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. A dog may continue to compete in this class after the owner has been notified by at least 2 different judges that the dog has won 3 qualifying scores in this class. However, a dog may not be entered or exhibited in this class in any rally trial after the owner has received official notification from the CKC that the Dog has won the title. No dog may be entered in both Rally Novice A and Rally Novice B at any one trial.

**RALLY NOVICE B**.- Any dog may compete in this class until a qualifying score in the Rally Advanced Class is earned. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

**RALLY ADVANCED A** - This class shall be for dogs that have won the Rally Novice (R. N.) title but have not won the Rally Advanced (R. A.) title or any CKC Novice Obedience title. No handler who has exhibited a dog through its CKC CDX (Companion Dog Excellent) title or instructed dog training classes shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. A dog may continue to compete in this class after the owner has been notified by at least 2 different judges that the dog has won 3 qualifying scores in this class. However, a dog may not be entered or exhibited in this class in any rally trial after the owner has received official notification from the CKC that the dog has won the title. No dog may be entered in both Rally Advanced A and Rally Advanced B at any one trial.

**RALLY ADVANCED B** - This class will be for dogs that have won the Rally Novice (R.N.) title. A dog completing the Rally Advanced (R.A.) title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

**RALLY EXCELLENT A** - This class shall be for dogs that have won the Rally Advanced (R.A.) title, but have not won the Rally Excellent (R. E.) title or any CKC Novice Obedience title. No handler who has exhibited a dog through its CKC CDX (Companion Dog Excellent) title or instructed dog training classes shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. A dog may continue to compete in this class after the owner has been notified by at least 2 different judges that the dog has won 3 qualifying scores in this class. However, a dog may not be entered or exhibited in this class in any rally trial after the owner has received official notification from the CKC that the dog has won the title. No dog may be entered in both Rally Excellent A and Rally Excellent B at any one trial.

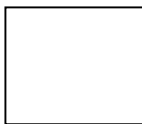
**RALLY EXCELLENT B** - This class will be for dogs that have won the Rally Advanced (R.A.) title. A dog completing the Rally Excellent (R.E.) title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

## GENERAL RULES GOVERNING THESE SHOWS

1. The Club reserves the right to remove any person from the show. The Show Superintendent shall have full control of the above shows and trials, which will be governed by CKC Rules.
2. Any dog excused by the Show Superintendent or the Show Veterinarian for any reason shall not, after being excused, compete in any class for any award for the balance of the show.
3. The show committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, or other misfortune, to either dogs, exhibitors patrons, or equipment.
4. A Judge or any person participating in any capacity at a Dog Show held under C.K.C. rules shall not be subjected to any indignity of any kind during the progress of the show and it shall be the duty and obligation of the Club holding the show to see that this rule is effectively carried out.
5. Exhibitors are solely responsible for the conduct or actions of their animals while they are on the show grounds.
6. **DOGS MUST BE READY FOR JUDGING.** The club will not be responsible for and is not obligated to provide any service for notifying owners or agents of breed or class judging. The ring shall not be held up waiting for exhibitors or handlers.
7. The owner of a dog entered in these shows is entirely responsible for any error in entering his dog, regardless of how or by whom the entry was made.
8. A dog once disqualified for any reason at a championship show held under these rules cannot again be shown at a show held under these rules until the dog has been examined by an official committee appointed by the CKC and the committee finds the dog is free from the condition which prompted the disqualification. Application for reinstatement must be accompanied with a fee set by CKC which shall be forfeited to the CKC if the examining committee is satisfied that the dog should remain disqualified. All awards earned by a dog shown in violation of this rule shall be canceled by the CKC and the owner of the dog is subject to disciplinary action.
9. Exhibitors are responsible for cleaning up after their dogs. Please exercise your dog BEFORE taking it to the Judging ring.
10. No entry fee will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the club.
11. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge, or barred from completion by action of the Show Committee.

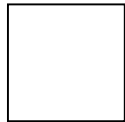
