*Entries will be closed automatically when the limit of 420 minutes of judging has been reached, even if the closing date for entries has not been reached. For Obedience, this is based on judging of 9 Pre-Novice, 8 Novice, 8 Novice Intermediate, 7 Open and 6 Utility entries per hour.

For Rally-O, this is based on judging 15 dogs per hour, and a 10-minute walk-through for each class level must be included in the scheduled judging times (walkthroughs may be extended by the judge if required).

The Club will accept entries on the DAY OF THE EVENT for **Rally Obedience Trial 2** and **Obedience Trials 1 & 2** only if the schedule will allow. Entries must be made at least one hour before the start of the TRIAL.

<p>* TEMPORARY COMPETITION NUMBER (EFFECTIVE MARCH 2, 2020) A Temporary Competition Number (TCN) must be obtained before submitting an entry for an event. The same TCN must be used for all event entries for a dog <u>until the dog is permanently registered</u>. Once a dog is permanently registered or has an ERN, the TCN will be replaced with the registration number or ERN. A TCN cannot be used for Listed Breeds (MCN) or dogs that will require a Performance Event Number (PEN) or Canine Companion Number (CCN). There is no fee to obtain a TCN however exhibitors will still be required to pay TCN Fees when entering events using a TCN. TCN Numbers may be obtained online via the CKC website where the number is issued instantly. Exhibitors may also mail in a printed application or contact CKC Shows and Trials by phone for a number. If your dog does not have a registration number or ERN and has already competed in a CKC event and earned points, scores or awards, before applying for a TCN online, exhibitors are encouraged to check their dog's profiles to determine if the CKC has already created a TCN for that dog. There will be a tab called TCN Dogs in the owner's Portal account.</p>

* Please note that a service charge of 10% will be assessed for entries sent online, by fax or any entry using a credit card or Interac for payment.

Canadian Residents, please note: The CKC has implemented an annual "non-member participation fee" for residents of Canada who are not members of the CKC. Check with the CKC for the current fee. The non-member participation fee is paid in any year a title is earned and covers all titles earned and dogs owned by that individual. In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.

The fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members. [NOTE: in 2022 the non-member fee is \$170.00 and CKC "basic membership" fee is \$54.00]

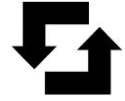

NOTICE TO OBEDIENCE TRIAL & RALLY OBEDIENCE TRIAL CLUBS (April 2022) from CKC:

At the December 2021 meeting of the Board of Directors [of the CKC], the following motion was carried... "THAT, for the year 2022, we adopt the following amendments as proposed by the Obedience Council to the Covid Obedience rules that are published on the website ..."

Please follow the link above to view all of the "allowable changes" to the rules. If there are Federal, Provincial or Municipal COVID restrictions in place at the time of the trials, RVO&FTC will be adopting the amended versions for Obedience rules [8.13], [9.6.3], [9.9.4], [9.9.5], [10.6.8], [10.7.3], [10.9.7], [10.10.4], [10.10.5], [10.10.8], [12.7.2], [12.13.4], [12.14.3], and for Rally Obedience: [4.3.2]

With respect to mask use in community settings, current Federal Public Health advice (at the time of publication of this document) states that "Masks are one of the most effective individual public health measures that we can use to protect ourselves and others from COVID-19." and "We recommend that you wear a mask in public indoor settings. You should feel free to wear a mask even if it's not required in your community or setting. This is an appropriate personal decision."

General Information

1. **It is the responsibility of the exhibitor to be familiar with the rules.** [CKC rules are posted on the CKC website](#) or copies of the Obedience and Rally Obedience Trials Regulations & Standards may be purchased from the CKC. Only certain sections of the rules are highlighted under General Information, so this should not be considered to be complete.
2. The precincts of the trials will include the entire interior of the building. Only dogs entered in official classes, including Exhibition Only, are permitted within the precincts of the trial.
3. Pinch/prong collars are not permitted within the precincts of the trial.
4. HEALTH – as per CKC rules [6.6.3], no dog may be brought onto the grounds or premises of a trial if it:
 - Is known to have distemper, parvovirus, kennel cough or other communicable disease;
 - Has recovered from distemper, parvovirus, kennel cough or other communicable disease within the last 30 days (prior to the event);
 - Has been housed within 30 days prior to the event on premises on which there existed distemper, parvovirus, kennel cough or other communicable disease.
5. CONTAGIOUS DISEASE - Refund of entry (less CKC fee) will be made for dogs that are under a veterinarian's care for contagious disease diagnosed after entries close. Request in writing must be submitted to Trial Secretary along with a letter from a veterinarian on or before the day of the Trial.
6. BITCHES IN SEASON – as per CKC rules [6.5.1], bitches in season are not permitted to compete. Refund of entry will be made for bitches who come into season after entries close. Request in writing must be submitted to Trial Secretary with certificate from a veterinarian prior to commencement of the Trial.
7. CKC Obedience rules state that “A judge officiating at a trial held under these rules shall not be subjected to indignities of any kind during the progress of the trial. It shall be the duty and obligation of the club holding the trial to see that this rule is effectively carried out.”
8. CKC Rally Obedience rules state that “It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer or competitor at a Rally Obedience Trial held under these regulations is not subject to indignities of any kind. The Rally Obedience Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.”
9. If entering a dog in either Obedience [Novice Intermediate, Open or Utility], or Rally Obedience [Rally Advanced, Excellent or Master Classes], PLEASE INDICATE JUMP HEIGHTS on entry forms.
10. Exhibitors must abide by any errors made in entering their dogs, regardless of how or who made the errors.
11. Judging schedules and any other pertinent information will be distributed to exhibitors after entries close.
12. All dogs that are foreign born and owned who enter Canada for the sole purpose of entering CKC events will require an Event Registration Number (ERN). An ERN must be obtained within 30 days of earning points, awards or scores to avoid cancellation. If factors beyond your control prohibit this or present a problem, please send a written request for a 30-day extension to the CKC. An ERN may be obtained by contacting the CKC.
13. The Club and the Trial Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability, in the event of accident or other misfortune to dogs, exhibitors or patrons. Neither the Club nor the Trial Committee will be responsible for dogs or property at the trial site.
14. If, because of riot, civil disturbance or other acts beyond the control of the Club, it is impossible to open or complete the Trial, no refund of entries will be made.
