**There will be "Day of Entries" permitted for Trial 2 on Saturday.  
Unfortunately, there will be no "Day of Entries" on Sunday as the trials are full.**

**PLEASE USE THE MAIN FRONT ENTRANCE WHERE YOU WILL PICK UP YOUR ARMBANDS AT THE FRONT DESK. THIS IS THE ONLY ENTRANCE THAT WILL BE USED DURING THE TRIALS.**

**Obedience Judging is based on: Utility - 6 dogs/hour, Open - 7 dogs/hour, Novice A, B, C, Intermediate - 8 dogs/hour & Pre-Novice - 9 dogs/hour.**

**Rally Obedience Judging is based on 15 dogs/hour plus a 10 min walk-through time per class.**

**Exhibitors are advised to check Judge's Sheets when posted and to immediately advise of any inaccuracies.**

**It is the exhibitor's responsibility to know the rules pertaining to the trials.**

**The precincts of the Trials will be the building and its surroundings.**

**No prong or spike collars permitted on site.**

**All exhibitors will be responsible for the clean-up of their own dogs anywhere on the trial site and surrounding areas.**

**There will be crating in the room adjacent to the Trialing area.**

**The Venue will be open at 8:00 am on Saturday and 7:00 am on Sunday.**
