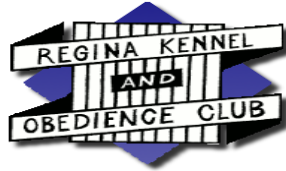
Facilities

- The trial will be held at the Regina Kennel and Obedience Club(RKOC) indoor facility
- This is a one ring event
- A crating area is available inside the building
- Competitors are responsible for their own crating, seating, food and water
- Self-serve coffee and tea will be available
- No canteen on premises competitors are responsible for their own meals

Dogs

- All dogs must be kept in a crate or on leash when not in the ring(due to limited space, no x-pens allowed)
- Handlers are responsible to keep their dogs quiet at all time.
- Handlers are responsible to clean up after their dogs. Clean up baggies will be provided.
- Handlers are responsible to ensure that their dogs do not eliminate in the front of the build or on neighbouring areas. There is a x-pen available in the back of the building for the dogs.
- Any dog engaging in aggressive behavior at any time will be required to leave the trail grounds. There will be no refund of fees in such instance.
- Any handler displaying inhumane or aggressive treatment of any dog, or other participants, judges or volunteers, in such instances; all legs earned will be null and void.

Move ups: will be permitted providing ample notice is given to the trial secretary or chairperson and the class has not begun.

GENERAL AGREEMENT/DISCLOSURE

- Entries must be accompanied by a signed waiver for each dog entered before your dog will be allowed to compete in the CARO trial.

I (we) agree that the club hosting this event, The Regina Kennel and Obedience Club (RKOC), has the right to refuse this entry for cause, which the organizing committee shall deem as sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog participate or be judged, I (we) agree to hold the organizing committee, the organization which it represents, including its members, officers and directors, owners of the premises upon which the event is being held and their employees, harmless from any claim or loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the premises, grounds, or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claims; and I (we) further agree to hold the aforementioned parties harmless from any claim for the loss of this dog by disappearance, theft, death, or otherwise, and from any claim for damage or injury, be caused or alleged to be caused by the negligence of the parties aforementioned, or by the negligence of any other person or any other cause or causes. I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting from injury sustained by any person or persons, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in this event, howsoever such injuries, death or damage to property may be caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.
