<u>Collars, Leashes & Harnesses</u>: 9.4.1: "Dogs must wear a properly fitted collar or harness approved by the judge. The harness will be constructed of plain, pliable material and will be designed so that there is minimal restriction of the

dog's movement. No special training tools, such as electronic collars, prong collars, head halters, choke chains, or nopull harnesses may be used during the search. Martingale collars are permitted. No odor emitting collars (such as nobark collars that spray citronella, or DAP calming collars) may be worn or present in the search area"
