ENTRY INFORMATION

1. Attention U.S. Exhibitors: A Personal cheque will be accepted, however, it must be payable in US funds and for the full entry amount. Personally discounted cheques will not be accepted. Do not mark cheque "payable in Canadian" or "funds at par". Your co-operation is appreciated.

2. If entering the same dog in conformation, obedience or exhibition only please use a separate entry form for each class.

3. An **INCOMPLETE ENTRY FORM WILL BE RETURNED**. Please ensure that your postal code is included. ALL NSF CHEQUES WILL BE CHARGED A \$30.00 SERVICE CHARGE.

4. Exhibitors must abide by the errors made when making the entry, regardless how or who made the entry.

5. An entry will not be accepted unless accompanied by the required fees.

6. The Cobequid Dog Club reserves the right to reject any entry subject to CKC rules.

7. Only dogs, which are eligible for registration or are registered by the CKC, may be entered in these Show & Trials.

8. Overpayment of entry fees up to a maximum of \$5.00 will be considered a donation to CDC Trophy Fund.

9. The Exhibitor is responsible for knowing and complying with the Dog Show Rules of the CKC.

10. There will be no prong or spike collars permitted at this venue.

11. Obedience Trial – Move Up A dog that is individually registered in the records of the CKC and has fulfilled the requirements for a title, in accordance with Section 9.4.2 and 10.4.2 of the Obedience Rules, may be moved to the next level of Obedience competition providing the transfer was submitted to the Trial secretary, **IN WRITING** by the owner or handler, one hour prior to the opening of the first trial, trial schedule permitting.

GENERAL INFORMATION

THE PRECINCTS OF THE TRIAL WILL BE THE SHOW BUILDING AND

ENTRANCE. The show premises will be **opening at 8:00 am each day** and on **Friday from 6:30-9:00pm (sharp) for early set up**. The Trial Judging will start at 9:00am unless entries warrant an earlier start. Judging schedule and identification will be mailed/emailed as soon as possible after the entry closing date The Cobequid Dog Club will use care and diligence for the welfare of the dogs and exhibitors, but will not be responsible for, or assume liability in the event of an accident or other misfortune to dogs, exhibitors or patrons. Judging will not be delayed to accommodate an exhibitor or handler who fails to have his/her dog in the ring when required. The Show Superintendent will be in full charge of the trials. Exercise pens will be restricted at the discretion of the Show Superintendent. Only dogs entered in the show are permitted within the show precincts please.

ATTENTION ALL CANADIANS WHO ARE NOT CKC MEMBERS

Effective January 1, 2011, the CKC has instituted an annual Non-Member Participation Fee for awards and titles for a CANADIAN non-member of the CKC. These fees apply only to dogs wholly owned by a non-CKC member and are not applicable to CKC members. Non CKC member participants must either purchase a CKC membership or pay the non-member participation fee within 30 days of notification or the CKC will cancel any awards and titles. RALLY CLASSES:

Novice A & B, Intermediate, Advanced A & B, Excellent A & B, Team Rally ring size is 40' by 60'.

EXHIBITORS ARE EXPECTED TO KNOW THE RULES AND REGULATIONS FOR DOG SHOWS, OBEDIENCE AND RALLY TRIALS. BOOKLETS ON DOG SHOW, OBEDIENCE AND RALLY TRIAL RULES ARE AVAILABLE FROM THE C.K.C A Bitch in season may not compete in Obedience or Rally Trials. Entry fees will be refunded ONLY if the Trial Secretary BEFORE commencement of the trial receives a Veterinarian's Certificate.

EVENT REGISTRATION NUMBER (ERN)

All dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will require an Events Registration Number (ERN)

To obtain an ERN number simply does the following:

1. Send a photocopy of the dog's registration certificate reflecting current ownership, for example AKC Registration Certificate with a written request for an ERN number.

2. Include with the above a cheque or money order in the amount currently required payable to the Canadian Kennel Club.

3. Ensure that you provide us with your full return address to enable the ERN number to be sent to you.

4. Faxed requests will be accepted. Please indicate your Visa/MasterCard number expiry date, cardholders name and signature.

This Event Registration Number MUST be applied for within 30 days of the first day of entering a CKC event. Dogs may be entered as "LISTED", however, failure to apply for an ERN number within 30 days will result in cancellation of any wins, awards or scores.

OFFICIAL JUNIOR HANDLING

There will be Junior Handling **OBEDIENCE** Saturday and Sunday. Registration will be in the Show Secretary's room in the morning, and must be done at **least one hour** in advance of the scheduled judging. Dogs competing in Junior Handling must be entered in one of the regular classes or in Exhibition Only. **A fee of \$2.00 for Junior Handling is required at time of registration.** Advanced notice of Obedience entry would be appreciated.
