Mixed breeds and unrecognized breeds with a Canine Companion Number (CCN) are permitted to enter these trials.

These events are being held under the rules of The Canadian Kennel Club. It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities. The Agility Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. No person may approach a judge either directly or otherwise, orally, in writing or electronically, to favour his entry. Disciplinary action will be taken against any person who violates this rule, or against a judge who fails to report any contravention of this rule to the CKC within 14 days of the action.

There will be no refunds for withdrawn entries after the closing date.

## Fee Structure

**Entry limit: 300 runs per day.**

**Parking limit: 25 cars per day. Ensure you indicate on your entry form which days you will require parking. Once the parking limit has been reached, any additional handlers who wish to enter will need to arrange to carpool or to be dropped off at the trial site.**

**All exhibitors are required to clean up after their dogs. Clean up bags and garbage bins are available for this purpose throughout the trial site. There continues to be those who do not take responsibility for their dogs, jeopardizing the club's access to this venue. For this reason, exhibitors who permit a dog to soil on the trial grounds without cleaning up will be denied entry to NKC shows and trials for one full calendar year.**

**There will be a BBQ on site on Saturday and Sunday for purchase (cash only.) Lunches will consist of chicken burgers, hamburgers, hotdogs, chips, bars, drinks, and other goodies.**

**A water hose and a small wading pool will be available on site. This trial will use manual timing. The Wall Jump and Broad Jump will not be used. The ring will be 100'x100' on grass, using snow fencing and metal gates. Dogs must be kept on a leash at all times when not in the ring. The use of flexi leashes, choke collars, prong collars, and electronic collars is strictly prohibited anywhere on the trial site, including the parking lot.**

### Liana Klohn Biography

*Thank you so much for having me out to Newfoundland to share my ideas and skills of agility and dog training with you. My passion for agility started about 20 years ago with a very special dog, who not only taught me a lot about dog training but also about patience, observation and innovative ideas in training methods. Colby kept me honest and did not allow for a lot of error on my part. It was frustrating at times, but he really made me a better handler and dog trainer.*

*I have been teaching locally and around North America for the past 12 years, enjoying meeting new teams and seeing the sites. Although I currently run medium-large dogs, I pride myself in understanding the challenges inherent with running smaller dogs.*

*In the past, I have competed at the International level with my border collie, Flight, and at a National level with my border collie, Scorch. Flight took us to 3 straight Regional Champ titles, as well as competing on 4 Canadian World Teams. I currently have 4 dogs: Flight and Scorch (the sweet boys of my life) and 2 sassy girls I love as well (4 year old Clever and 18 month old Siren).*

*Over the past few years, I have adopted a more European style of handling, one that allows me to be out in front of my dog more often, creating more speed and efficiency. More recently, due to a knee injury, I have had to adapt to more distance handling (a challenge indeed!). When teaching, I do not believe in the 'cookie cutter' approach to training and continue to cater to all handling methods – pushing each team to broaden their skill sets. I believe each team is unique and warrants individualized ideas and feedback.*

*I look forward to working with each one of you and providing you with the tools necessary to build a strong, confident team, all the while having fun running in a stress-free environment.*
