**TDX TRACKS-** the meeting place will be the parking lot of the Chevron Gas Station & Store at the corner of 8 Ave. & 176 St. Surrey, BC where the draw for tracks will take place on **October 24, 2021 at 10:45 am** Any primary entrant(s) who is/are absent at the assigned time will forfeit their position to the first available Alternate(s) present.

#### **Disclaimer of any Liability**

In attending this test, competitors, spectators and guests acknowledge they do so at their own risk and that of any dog. They also agree they will not hold liable the C.K.C., The Western Great Dane Club of B.C., it's club or test officials, the Judge or the landowner(s) for any loss, damage or injury, however arising, to themselves, their dog(s), or any chattels.

<u>Bitches in season</u> will be allowed to compete, but will run last. Please advise Test Secretary **immediately** upon arrival at the meeting place.

Manure Please note the possibility exists that manure may be on fields

<u>Awards and No-Host luncheon</u> A ribbon will be presented to all successful competitors by the judge at the conclusion of a successful track. Also the club will award keepsake trophies to successful competitors. Due to Covid-19 there will be no luncheon held after the test.

<u>Refunds</u> Withdrawn entries after closing date will only be refunded where there is an "Alternate" available who chooses to fill that assigned entrant's vacancy on test day. Alternates will be contacted in catalogue order and advised of the opening. They may choose to accept the spot and become responsible for the entry fee or decline and bear no financial obligation. Anyone on the "Alternate List" may request a refund at any time prior to test day. Entries will be refunded within 10 days of the test date to those on the alternate list that did not participate in the test.

**Statement** It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Tracking Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

#### Non-member participation fee – Effective January 1, 2011

- a) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of  $\mathsf{CKC}$ .
- b) in order to protect the awards/title earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of the notification will cause all the awards and titles to be cancelled.
- c) These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.

COVID-19: A gallery consisting of handlers registered in the test, and test volunteers is permitted. Social distancing must be adhered to. A "Home Base" will be established at the test site and participants are asked to keep the required distance while waiting for your turn if possible to stay in your vehicle. Only the Judge, Track layer, Superintendent, dog and handler will be allowed at any given site.

Articles will be carried and scented by the track layer. Extra articles will be kept in a plastic bag. All participants are encouraged to bring a bag for articles and protective gloves if you want to pick up the article after your dog has indicated it. Alternatively, you can leave the article on the ground for the track layer to pick up.

This test will be held in accordance with applicable Covid-19 Guidelines as outlined by Federal, Provincial and Municipal governments Public Health Officers.
