
GENERAL INFORMATION - MUST READ

- Rules (click for CKC FT rules): Retriever Trial Rules and Regulations Books are available from the Canadian Kennel Club, 100 89 Skyway Ave., Etobicoke, ON M9W 6R4. Note: To enter the Junior stake the dog must be between 6 months and 2 years of age on the day of the trial.
- **Entries:** Entry Forms must be completed in full, signed and accompanied by ENTRY FEES AND, if applicable \$10.50 Temporary Competition Fee. Owners are responsible for errors on entry forms or where hand-writing is not clearly legible. No phone, late or day of entries will be accepted. A separate entry for EACH dog in EACH stake is required on an official CKC entry form.
- *NEW**Temporary Competition Number: Dogs without a permanent CKC or ERN registration number, a Temporary Competition Number (TCN) must be applied for (online, paper application, or contact Show & Trials Division CKC 1-855-364-7252), BEFORE SUBMITTING AN ENTRY FEE FOR AN EVENT. The same TCN must be used for all event entries until the dog is permanently registered.
- <u>Awards:</u> Official CKC Rosettes will be awarded to all placements and qualifying dogs at the end of the field trial day. Please Note CKC Ruling: Canadian Resident non CKC Members running a wholly owned dog cannot win a placement towards awards unless they pay a non-member participation fee or a membership fee to the CKC.
- Refunds: Entry fees will not be refunded after Friday, September 16, 2022. In the event that a dog is absent, disqualified, excused by a judge or barred from competition by action of the Field Trial Committee or the Canadian Kennel Club, no refund of entry will be made. Bitches in season are NOT eligible for entry and are not allowed on the trial grounds. Bitches may be subject to vetting. Entry and Temporary Competition fees paid for any dog withdrawn because of estrus, illness or death shall be refunded in full minus a \$10 admin fee if notification in writing is accompanied by a veterinarian's certificate. All refunds must be requested in writing and once the catalogue has been emailed, will be less CKC event fees, NRCC fees and Temporary Competition fees if applicable. Refunds are at the discretion of the Field Trial Chair and Secretary.
- **Running Order:** Running order will be drawn at the home of the Field Trial Secretary at the time and date of closing. Males and females will be run in the order of the draw or at the discretion of the Marshal. Bitches in season may not compete and must be withdrawn. Any dog not appearing within 15 minutes of its time to run may be disqualified.
- Start Times: Start times will be adhered to as strictly as possible and handlers are asked to be at their stake and checked in with their Marshal a minimum of 15 minutes prior to start time regardless of running order. Please check in with the Field Trial Marshal at Test Headquarters Swamp Dog Farm, 7531 Albert Rd., Black Creek 30 minutes before start time. We ask everyone to drive SLOW on the roads leading to Test Headquarters and Field Trial locations. This is a farming community, watch for children, farm machinery, animals, farm dogs be aware and obey ALL posted speed limits.
- **Clothing:** Spectators shall not wear white or distinctively light clothing at any time but handlers may wear a white handling jacket.
- **Birds:** Dead ducks and pheasants may be used in each stake.
- **Grounds:** Saturdays Open Stake will be held on Private grounds. All other trials will be held at Swamp Dog Farm. All dogs when not running in their trial MUST be ON LEASH and under control even when airing. Bring adequate shade, sunscreen, water and cover for hot or rainy weather for both you and your dog(s). Be prepared and carry a first aid kit. YOU MUST pick up after your dog and airing is only allowed in areas designated by Test Headquarters and Trial Marshals. Please respect the landowners that have so graciously allowed us on their land by obeying all signs, removing all garbage and debris. Park ONLY in designated areas.
- Indignities: All participants must be familiar with Chapter 21, Section 7 of the Field Trial Rules and Regulations. In summary, it provides that any Person participating in a Trial shall not be subjected to an indignity of any kind. Violations of this rule shall be dealt with in accordance with the rules and regulations of the Canadian Kennel Club.
- <u>ALL Competitors:</u> BY ATTENDING this Field Trial, competitors and spectators acknowledge that the Upper Island Retriever Club, trial officials and the Landowners involved do not accept liability for any loss, damage or injury incurred by exhibitors or dogs.

- **Concession:** There will be no concession on the Field Trial grounds.
