## **REMINDERS TO EXHIBITORS**

**Exhibitors, through submission of entry, acknowledge that they are knowledgeable of AAC rules and regulations, including but not limited to the following:**

- This event is open to all dogs being at least 18 months of age, purebred or mixed breed, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury or illness which may effect the dog's physical or mental performance, or any dogs showing signs of aggression.
  - Obstacles shall be chosen from those described in the current edition of the rules and regulations of the AAC.
  - No collars, food, toys or other aids or devices shall be permitted on the course at any time, including during familiarization and course-walking. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children.
  - All dogs must be penned, crated or on leash when not in the ring. All dogs must be under control when exiting the ring. Any dog engaging in aggressive or out of control behavior upon exit of the ring may be disqualified and / or required to leave the show grounds and NO REFUND of fees shall be given.
  - Please pick up after yourself and your dogs.
  - Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may be asked to leave the show grounds and no refund of fees paid will be made.
  - If an exhibitor must be asked to leave the show grounds for any reason, they will not be issued a refund.
  - There will be no refund after the closing date for dogs that are withdrawn, with the exception of bitches in season or sick/ injured dogs if we are provided with a vet's certificate

**General Agreement**

In consideration of the acceptance of this entry by K9 Cliffhangers Dog Agility Club (the "Organizing Club"), and Highrun Building ("Property Owners") and the opportunity to have the Dog participate, compete in and/or be judged at this event or trial (the "Event"), I, the undersigned, agree as follows:

1. I certify that I am the actual owner of the Dog, or that I am the duly authorized agent of the actual owner of the Dog and that the Dog is not a hazard to persons, property or other dogs.
2. I agree that AAC or the Organizing Club or Property Owners for the Event may refuse my entry for any reason that it deems to be sufficient.
3. I understand and acknowledge that participation in the Event carries certain risks, including, but not limited to injuries (including serious injuries and death) to myself, the Dog, another dog under my control or persons attending as my guests (my "Related Parties"), damage to property and other losses. I waive any and all claims that I have or may have in the future against, and release from all liability and agree not to sue AAC, the Organizing Club or any of the directors, executives, committees, representatives, employees, volunteers or agents of either AAC or the Organizing Club (the "Personnel") or Property Owners for any injury, death, property damage or other loss that I or my Related Parties sustain due to any cause whatsoever, including negligence, breach of contract, breach of duty, statutory or otherwise, or mistakes or errors of judgment of any kind.
4. I assume full responsibility for the conduct of myself and my Related Parties during the entirety of the Event. I agree to indemnify and save harmless AAC, the Organizing Club and the Personnel and Property Owners from and against any and all claims that may be made against them or costs, fees, expenses or liability (including, without limitation, lawyers' fees on a solicitor and own client basis) incurred by AAC, the Organizing Club or the Personnel or Property Owners that may arise due to: a) any act or omission of myself, my Related Parties or any party for whom I am liable at law; or b) aggressive behaviour by the Dog or any other dog under my control.
5. I have read, and do understand the rules of competition and the additional rules (if any) appearing in the trial schedule for the Event, as well as the policies of AAC pertaining to discipline (collectively, the "Rules"). I agree to abide by the Rules and to conduct myself and the Dog in accordance with the Rules. I understand that myself and/or the Dog may be subject to disciplinary procedures or sanctions for breach of the Rules and agree to respect and be bound by any disciplinary decision made by AAC.
6. I understand that AAC and/or the Organizing Club may, in the course of administering the Event or conducting its activities generally, collect, use or disclose my personal information and that any personal information collected, used or disclosed by AAC and/or the Organizing Club and/or Property Owners will be treated in accordance with AAC policy and applicable privacy and

personal information laws. I hereby consent to the collection, use and disclosure by AAC and/or the Organizing Club of my personal information.

7. I attest that to the best of my knowledge, I do not have COVID-19 at the time of attending this event, and understand the risks of unknowing exposure to this and other illnesses by or to myself, my family, other participants, and third parties. I have not been tested and found positive; am not waiting for test results; and do not have symptoms. I agree that I will not knowingly expose others to any illness I may have or be at risk to have. I will follow all AAC and/or the Organizing Club rules and requirements to reduce any exposure and possibility of contracting or spreading the virus. I will also fully cooperate with and follow any City, or Provincial guidelines that have jurisdiction in the area in which the event is taking place. If any of the above should change prior to my arrival at the trial site or during the completion of the event that is the subject of this consent, I will inform AAC and/or the Organizing Club and proceed accordingly in light of the new information.
8. I agree that I am attending this AAC and/or the Organizing Club event entirely at my own risk and assume all risk and full responsibility for my own health, wellbeing, and safety during this class or event. I fully agree that AAC and/or the Organizing Club, the owners/board members, employees, assistants and volunteers are in no way liable for any present or future COVID-19 exposure incurred at any time by any person, in attendance or not in attendance, during or after this event. I hereby waive and release AAC and/or the Organizing Club, the owners/board members, employees, assistants and volunteers from any and all liability for damages or personal injury to me, my dogs or my property.
9. Further, I hereby indemnify and hold harmless AAC and/or the Organizing Club the owners/board members, employees, assistants and volunteers from any and all claims by or liability to any third party arising out of my participation in the Site and Club event. Any liability to anyone for any incident involving myself, the location, or those pets or actions of other participants and spectators will be my sole responsibility and I assume all financial liability and will also assume all and any financial costs associated with my actions.
10. I have been given the opportunity to read and understand the terms of this Agreement before signing it, and have in fact done so. I understand that by signing this Agreement, I am restricting my legal rights and I sign this Agreement voluntarily and of my own free will.

### **K9 CLIFFHANGERS TRIAL PROTOCOL:**

1. Full refunds for anyone that pulls due to illness
2. Everyone must wear a mask on site, except when in personal vehicle
3. All ring crew and judge to wear masks
4. Masks can be removed while running your dog and put on at end of run prior to leaving leash up area or if you prefer to keep it on that's your choice
5. Scorekeeper is outside of the building
6. Hand washing station available
7. Hand sanitizer available (club responsibility to provide)
8. Split walk throughs. Course builders walk course first and as they leave others may proceed with walk through
9. Specific spots for ring crew to sit around the barn. Must wear gloves that can be sanitized or thrown away. Only 2 ring crew per run to keep number of people in the barn to 5 including timer/scribe and judge
10. Anyone not following protocol will receive one warning and second time will be excused from the trial
11. Be mindful of others when in the parking lot and keep your distance from vehicles
12. Keep groups to a minimum when outside talking
13. Maximum 5 people for course building
14. Restricted to competitors only, no invited guests or family (except for people under age of 19)
15. Everyone on site must sign waiver including judge, gatekeeper, timer and scribe (if not entered in trial)
